### Amendments to Article INPURPOSE

## November 23, 2012

- 2. (a)Operation People for Peace Inc., is organized exclusively for charitable, religious, educational, and scientific purposes, the making of distributions to organizations that qualify as exempt organization under section 501(c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code.
- 2.(b) Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the organization is then located, exclusively for such purpose or to such organization or organization, as said Court shall determine, which are organized and operated exclusively for such purposes.
- 3. Operation People for peace is providing advocacy for the underserved and underrepresented and those whom are disenfranchised. We hope to achieve our goals by working and associating with other non-exempt organization through an awareness campaign concerning our purposes. Our purposes will not be limited to this action but as well as distributing through donating food, clothing, shelter, awareness campaigns, educational needs, a concern for incarcerated individuals for reducing recidivism with prison systems, and other needs for assisting the underclass and other needs that necessitate during Disastrous, such as; Hurricane, Floods, Fire, clean air, land, and water or Homelessness or any other needs to the disenfranchised communities, from acts of God or Industry. In additional, from time to time this organization would affiliate itself in concert with other approved non-exempt organization and federal, state and local government and quasi government agencies to become an advocate in the area of disastrous through non-violent direct action, lectures, and disseminations of literature and other means of public instruction. In order to conduct these activities we would utilize community volunteers and staff from Operation People for Peace, Inc. and all other agencies that have been fore mention. All activities where they would be conducted as mentioned would be located in various community agencies outlets and churches including but not limited to public media outlets.
- 4. Operation People for peace, Inc. would recommend and advise the underserved and underrepresented communities or individual to receive their legal rights to appeal before government agencies concerning inadequacies that might exist, in their communities to advocate their rights in a non-violent actions. This organization would contact and advise other non-profit exempt agencies or profit legal assistants that would articulate the issues of the underserved. This organization would go to governmental agencies for assistance in legal matters including contacting the US Dept of Justice to voice the concerns of the underserved and underrepresented.
