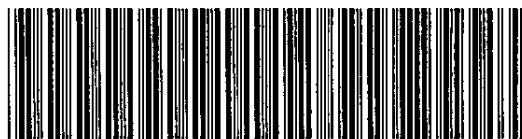

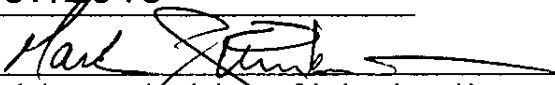

Amendment of Article III

The specific purpose for which this corporation is organized is:

Trinity Youth Sports, Inc is organized exclusively for the education and development of youth in the area of baseball. Our mission is to develop and strengthen the fundamental physical and mental skills associated with the game of baseball.

No part of the net earnings of the corporation shall inure the benefit of or be distributed to its member, trustees, officers, directors or other private persons and no officer of the Corporation or any private individual shall be entitled to share in the distribution of any of the corporate assets on dissolution of the Corporation.

Notwithstanding any other provision of these articles, the Corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)3 of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170 (c) 2 of the Internal Revenue Code, or the corresponding section of any future federal tax code.
