**ARTICLES OF INCORPORATION
OF
THE QUINCEAÑERAS ASSOCIATION, INC.**

We, the undersigned incorporators, desiring to form a non-profit corporation under the provisions of Chapter 617 Florida Statutes, do hereby execute and adopt the following Articles of Incorporation:

ARTICLE I - NAME

The name of this corporation is The Quinceañeras Association, Inc.

ARTICLE II - PRINCIPAL OFFICE

The address of the principal office of the corporation is 4301 Park Boulevard, Pinellas Park, Florida, 33781. The mailing address is the same.

ARTICLE III - DURATION

The term of existence of the corporation is perpetual.

ARTICLE IV - PURPOSES

The corporation is organized for the following purposes:

- A. To provide the opportunity for the exchange of ideas and opinions and for study and discussion of various technical aspects of businesses developed around the celebration of Quinceañeras; to develop and encourage high standards of service for members serving Quinceañeras businesses; to acquire, preserve, and disseminate data and information to members relating to Quinceañeras businesses; and to network with other non-profit organizations or individuals who wish to share ideas and suggestions.
- B. To do such other things as are incidental to the purposes of the corporation or necessary or desirable in order to accomplish them.
- C. To perform any lawful act or activity for which corporations not-for-profit may be

formed under the Florida Not-For-Profit Corporation Act.

ARTICLE V - DIRECTORS

The manner in which the directors are elected or appointed shall be as stated in the bylaws of the corporation. The number of directors shall not be less than three. The names and addresses of the persons who are to serve as initial directors until the first annual meeting of the corporation, or until their successors are elected, are:

ARTICLE VI - OFFICERS

The affairs of the corporation are to be managed by a President, one or more Vice-Presidents, a Secretary, and a Treasurer. The offices of Secretary and Treasurer may be combined in one person. Such officers will be elected in accordance with procedures set out in the bylaws. The names of the persons who are to serve as officers of the corporation until the first meeting of the Board of Directors, or until their successors are elected, are as follows:

ARTICLE VII- MEMBERS

The membership of this corporation shall be the directors named herein, and all those in the future who may take their place as successor directors.

ARTICLE VIII - BYLAWS

The bylaws of the corporation are to be made, altered, or rescinded by the directors of the corporation.

ARTICLE IX - AMENDMENTS TO ARTICLES

These Articles of Incorporation may be amended by a majority vote of the Board of Directors of this corporation.

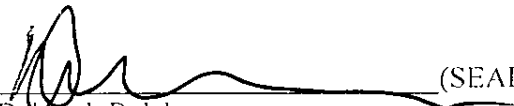

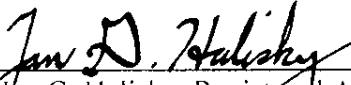
