- 2). a. Said organization is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code.
- **b.** Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

- 1. Martin-Smith Animal Rescue will receive the animals by Dr. Caroline Smith, a veterinarian in Louisville, Kentucky. Dr. Smith's friends have trailers and they will transport animals to her facility in Kentucky.
- 2. Martin-Smith Animal Rescue will inform the general public of our activities through the use of newspaper advertisement and billboards.
- 3. Martin-Smith Rescue will only be in a position to receive animals. We will go to locations that have abused and/or neglected animals and will take them into our facility.
- 4. Receiving animals will be conducted in Louisville, Kentucky at the residence of Dr. Caroline Smith.
- 5. The animals will be housed at either the residence of Dr. Caroline Smith or at a donor's property, which is designated for animals.
- 6. Smith-Martin Animal Rescue is a 501 (c) (3), which Dr. Caroline Smith and Richard E. Martin own. Richard E. Martin will be financially responsible for its use.
- 7. Martin-Smith Animal Rescue can accommodate and provide medical help for 10 or more animals.
- 8. In addition to Dr. Caroline Smith donating 10 hours per week to Martin-Smith Animal Rescue, we will have volunteers who will counsel the owners of injured animals.
