

ARTICLES OF INCORPORATION OF FLORIDA FRIENDS OF THE GULF, INC.



I, the undersigned sole subscriber to these Articles of Incorporation, being a natural person competent to contract, hereby execute this document for the purpose of becoming a non-profit corporation under the laws of the State of Florida.

ARTICLE I: NAME

The name of this corporation shall be:

FLORIDA FRIENDS OF THE GULF, INC.

ARTICLE II: PRINCIPAL OFFICE

The principal place of business of this corporation shall be 1111 Paul Russell Road, Tallahassee, Florida 32301 but it shall have the power to transact business in any other place or places both within and without the State of Florida and throughout the world.
