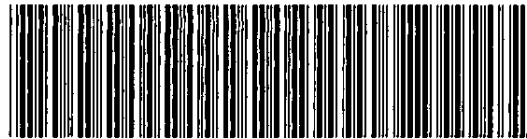

**DAGSY M. CONTRERAS**, being first duly sworn upon oath states as follows:

1. I make this Affidavit in support of my request to incorporate a new Non-Profit Florida corporation under the name "Second Chance International Foundation Inc." under Document Ref No. W11000023645.
2. I was the managing member of a Florida LLC., named "Second Chance International Foundation LLC".
3. On April 20, 2011 I filed for dissolution of the LLC, under Document Number L09000017527, since I had mistaken formed a LLC instead of a Non-Profit, as I intended.
4. We will not conduct business any longer under the "Second Chance International Foundation LLC" and we do not intend to refile using that LLC name, at any time, now or in the future.
5. Instead we wish to use a new but similar name as a Non Profit, namely, Second Chance International Foundation Inc.
6. There is no intent to defraud or deceive. We simply have dissolved the old corporation voluntarily and reincorporated as a Non Profit under the same name. We do not intend at any time to revoke the dissolution of the LLC.

7. We have established a "brand" with the "Second Chance" name and we do not wish to hinder those previous branding efforts.

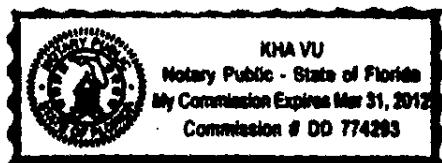


#### Article VII
