#### ARTICLES OF INCORPORATION FOR PROMISETOWN PRESCHOOL AT PVPC, INC.

#### ARTICLE 1 NAME

The name of the corporation is Promisenown Preschool at PVPC, Inc.

### ARTICLE II PRINCIPAL OFFICE AND MAILING ADDRESS

The initial principal office and mailing address is 4510 Palm Vailey Road, Ponte Vedra Beach, Florida 32082.

### ARTICLE III COMMENCEMENT OF EXISTENCE

The existence of the corporation will commence on the date of the filing of these Articles of Incorporation.

#### ARTICLE IV PURPOSE

This corporation is organized exclusively for charitable, educational, and scientific purposes including, for such purposes, the making of distributions to organizations that qualify as exeropt organizations under Section 501(c)(3) of the Internal Revenue Code, or the corresponding Section of any future federal tax code (the "Code"). Principally, this corporation is formed to provide a Christian education and environment for children of our community between the ages of one and five years of age, before the commencement of statutory and obligatory education.

### ARTICLE V BOARD OF DIRECTORS

SECTION 1. The concerns, direction and management of the affairs of this corporation shall be vested in the Board of Directors. This corporation shall have no members.

SECTION 2. The Board shall at all times consist of at least three (3) directors, and may have such additional directors as provided in the Bylaws of the corporation.

SECTION 3. The method of electing directors shall be set forth in the Bylaws of the corporation.

#### ARTICLE VI. ACTIVITIES

No part of the net earnings of the corporation shall imme to the benefit of, or be distributable to, its directors or officers, or other private persons, except that the corporation shall be anthorized and empowered to pay measurable compensation for services rendered and to make to payments and distributions in furtherance of the purposes set forth in Article IV above. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervone in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these Articles of Incorporation, the corporation shall not carry on any other activities not permitted to be carried on (i) by a corporation exempt from federal income tax under Section 501(c)(3) of the Code, or (ii) by a corporation, contributions to which are deductible under Section 170(c)(2) of the Code.

#### ARTICLE VII DISSOLUTION

Upon dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Code, or shall be distributed to the federal government, or to a state or local government, for public purpose. Any such assets not so disposed of shall be disposed of by a court of competent jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations as said court shall determine which are organized and operated exclusively for such purposes.

### ARTICLE VIII INITIAL REGISTERED OFFICE AND AGENT
