Said organization is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under the section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code. The business activity for said organization is as follows: the corporation is not for profit agency dedicated to providing Behavioral Mental Health Services to children and families throughout Florida. Our mission is to improve lives and strengthen families by mobilizing and engaging the caring power of communities and enhancing natural support systems using strength
