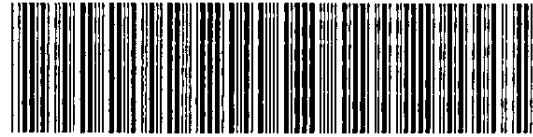

ARTICLES OF INCORPORATION

We, the undersigned subscribers, hereby associate ourselves together for the purpose of becoming incorporated under the laws of the State of Florida, Florida Statutes 617 applicable to corporations not for profit.

ARTICLE I.

The name of the Corporation shall be Tremendous Tampa District AME Community Development Corporation.

ARTICLE II

The principle office of this Corporation shall be located at Mt. Zion AME Church Riverview, 5920 Robert Tolle Dr., Riverview, FL 33578

ARTICLE III

The general purpose of the Tremendous Tampa District AME Community Development Corporation is to provide charitable, educational, technological and community development including housing and economic development. The Corporation may maintain and operate offices throughout the state of Florida.

To accomplish the general purpose of the Corporation, it shall have the power to purchase, take, receive, lease, devise or bequest or otherwise acquire, own, hold, improve, use or otherwise deal in and with real or personal property, or any interest therein, wherever situated.

ARTICLE IV

The affairs of the Corporation are to be managed by a Chairperson, Vice-Chairperson, Secretary and Treasurer who must be members of the Board of Directors.

Initially directors and officers are appointed while subsequent directors and officers will be elected or appointed by majority vote during directors meetings.
