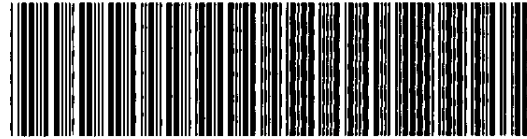

ARTICLES OF INCORPORATION
OF

or repeal any Article adopted by the members if the members specifically provide such Article not subject to amendment or repeal by the Directors.


