ARTICLES OF INCORPORATION

In compliance with Chapter 617, F.S. (Not for Profit)

ARTICLE I – NAME

The name of the Corporation is NEW BEGINNINGS INTERNATIONAL OUTREACH, INC

ARTICLE II – PRINCIPAL OFFICE

The street address of the principal office of the Corporation is 238 Jackson Avenue, Greenacres, FL 33463.

ARTICLE III – PURPOSE

The corporation is organized as not for profit under the laws of the State of Florida to promote the general education and social welfare of the community exclusively for charitable, religious, educational, scientific and other activities as specified under Section 501(c)(3) of the Internal Revenue Code, including for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal revenue Code, or the corresponding section of any future federal tax code.

The purpose of the corporation is:

To ameliorate, and offer transitioning assistance, to the economically disadvantaged, collaborate with local agencies and public entities to create a continuum of care that will empower clients to accomplish economic self sufficiency; and, to conduct and transact in connection therewith any lawful business not pecuniary profit and not prohibited by Chapter 617, Florida Statutes.

ARTICLE VI – LIMITATIONS

No part of the net earnings of the corporation shall inure to the benefit of or be distributable to its members, trustees, officers or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III hereof.

No substantial part of the activities of the corporation shall be the carrying on of propaganda or otherwise attempting to influence legislation and the corporation shall not participate in or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

Notwithstanding any other provisions of these articles, the corporation shall not carry on any other activities not to be carried on (a) by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under Section 107(c)(2) of the Internal Revenue Code or the corresponding section of any future federal tax code.

ARTICLE VII – DURATION/DISSOLUTION


The duration of the Corporation's existence shall be perpetual until dissolution.

Upon the dissolution of the Corporation, assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a court of competent jurisdiction of the county in which the principal office is there located, exclusively for such purposes or to such organization or organizations, as said court shall determine, which are organized and operating exclusively for such purposes.

ARTICLE VIII- REGISTERED AGENT


