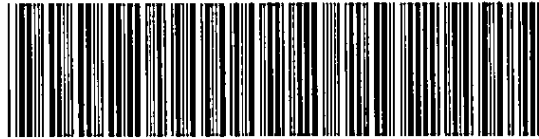

Title Page Add: Founded 5/26/11 (between Life Church Gulf Breeze, Inc & Articles of Incorporation line)

Articles of Incorporation - FOURTH : The number of directors of the corporation is four.

Constitution - II : The Church office is presently located at 101 Norwich Drive, Gulf Breeze, Florida

Constitution - IV Articles of Faith - first paragraph now reads: Life Church Gulf Breee has been formed under the Lordship

of Jesus Christ. Our heart is to be a gathering of believers that are a part of the church universal that operates under Jesus Christ who is head of the church. We desire to be led by the power of the Holy Spirit to fulfill the will and purpose of God the Father for our fellowship, and our part in the church universal. At Life Church it is our desire to teach the word of God verse by verse, being a hub for ministry, giving people a platform to step out in faith and follow the Lord's leading in their life. It is our desire to support each other in the ministries the Lord calls us to corporately and individually. We are not a denominational church, but not opposed to them. We recognize that Jesus is building His church and that all born again believers make up His body on earth. We believe that only God's love in Christ by the Holy Spirit can bring about true fellowship among believers.

Constitution - IV Articles of Faith 8: We believe marriage is ordained by God as an institution between a man and a woman only; with the purpose of reflecting God's heart for the churches relationship with His son Jesus Christ: the church being represented as the bride, and Jesus Christ represented as the husband. Life Church does not recognize same sex marriage as a biblical doctrine, therefore we do not support or officiate these marriages.



II Church Officers

Section 3: The duties and role of the Elders

b. The elders are to be involved in the decision making of the church. They are to prayerfully and biblically direct the congregation. The decision making of the church will be consensus of the board of elders. All elders have the responsibility by prayer to achieve unanimity on all major decisions. If a unanimous decision cannot be reached in the meeting, elders will wait and pray on the issue until the next scheduled meeting and visit the topic again in the hopes of a unanimous decision.

d. The board of elders will meet at least once a quarter (monthly preferred) at a time and place to be determined by the board. Special meetings may be called by the pastor if needed. Issues may be agreed upon, if possible, by email or text to the elder group between meetings.

e. The board of elders shall be no less than 3 (including the pastor) and no more than 7. (paid Life Church staff elders must be outnumbered 2 to 1 by non-paid church elders) The Apostles publicly recognize the elders. We have no apostolic authority today, therefore the senior pastor shall prayerfully appoint the first elder board, and then the elders from then on shall prayerfully appoint all other elders. Any appointment of an elder must be done by unanimous decision of all active elders.

Section four: The duties and role of the Deacons

Last paragraph reads: When the church leaders (elders) recognize a particular need to be filled by a deacon (for example, care for the poor, facilities, youth, or children's ministry, and hospital visitation) then the elders should look in the congregation for Spirit-filled men or women for those job(s). The elders should consider people who are spiritually qualified and then publicly recognize them as deacons and/or deaconesses.

Section five: Church Staff

The staff of the church shall consist of senior pastor and other staff members determined by the elders. The senior pastor shall have the oversight of the other staff members and shall have the authority to employ and dismiss staff members with counsel of the elders

Third paragraph should read:

Salaries for all staff including senior pastor shall be equal at hire. Full time married head of household salary, 70,000.00, part time married head of household, or non-head of household full time salary, \$35,000.00, Full time single salary, \$35,000.00, and part time single salary, \$17,500.00.

III Ordination

Men called to the pastoral ministry and who desire a local congregation are best ordained by their own congregation. It is the privilege of the local congregation to ordain its own pastors, elders, deacons and missionaries. Who could know with greater certainty the call of God upon the life of a man than his own congregation. This ordination process will be carried out by the elders of this congregation.
