We the undersigned, do hereby associate together for the purpose of forming and beginning a corporation not for profit under the laws of the State of Florida and the with Secretary of the State of Florida these Articles of Incorporation.

Article I

Article III

<u>Purposes</u>

Colegio Teológico Del Sureste Inc / Southeastern Theological College Inc. is organized to provide theological and biblical training by offering programs conductive to certificate, associates, bachelor's, master's and doctoral degrees in Christian Counseling, Pastoral Theology, Biblical Studies, Christian Education, Community Leaderships an Missions, to the men and women of different denominations' in order to prepare them for religious vocation. It will provide support and services in positive environment in which they can develop their social, physical, spiritual skills and talents though an integral Christian Education in the state and out of country deems necessary

The corporation is organized exclusively for charitable, religious, educational, literary or scientific purposes within the meaning of Section 501 © (3) of the Internal Revenue Code or corresponding section of any future federal tax code.

Notwithstanding any other provision of this document, the organization shall not carry on any activities not permitted to be carried on (a) by an organization exempt from federal income tax under federal tax code, of (b) by an organization, contribution to which are deductible under section 170 (c) (2) of the Internal Revenue Code, or corresponding section of nay federal tax code.

No part of the net earnings of the organizations shall inure to the benefit of, or be distributable to its members, trustees, officers or other private persons, except that the organizations shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distribution in furtherance of the purpose forth in the purpose clause hereof.

Upon the dissolution of the organization, the Board of Directors shall, after paying or making provision for the payment of all the liabilities of the Corporation, dispose of all of the assets of this corporation provided the shall at that time qualify as an exempt organization under Section 501 © (3) of the internal Revenue Code. In the event the organization is not active at the time of the dissolution of this Corporation, the Board of Directors shall dispose of all assets of this Corporation to another organization (Southeastern Hispanic Church of God) organization under Section 501 © (3) of the internal Revenue Code as the Board of Directors shall determine. Any such assets no so disposed of shall be disposed of by the Circuit Court of the county in which the principal office of the Corporation is then located exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
