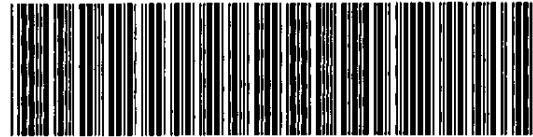





ARTICLES OF INCORPORATION
OF
FOR THE CHILDREN OF GUYANA, INCORPORATED
(A Florida "Not for Profit" Corporation)

The undersigned, acting as incorporator of a corporation under Chapter 617 of Florida Statutes, adopts the following Articles of Incorporation:

ARTICLE I. NAME OF CORPORATION:

The name of the corporation is: FOR THE CHILDREN OF GUYANA, INCORPORATED.

ARTICLE II. PRINCIPAL OFFICE:

The principal office of the corporation is located at:

ARTICLE III. CORPORATE PURPOSES:

The general nature of the Not For Profit business to be transacted by this corporation is as follows, including but not limited to:

1. This corporation is formed exclusively for charitable and educational purposes within the meaning of section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law."
2. To aid, support, and assist by gifts, contributions, or otherwise, other corporations, community chests, funds and foundations organized and operated exclusively for charitable or educational purposes, no part of the net earnings of which inures to the benefit of any private shareholder or individual, and no substantial part of the activities of which is carrying on propaganda, or otherwise attempting to influence legislation.
3. To do any and all lawful activities which may be necessary, useful, or desirable for the furtherance, accomplishment, fostering, or attaining of the foregoing purposes, either directly or indirectly, and either alone or in conjunction or cooperation with others, whether such others be persons or organizations of any kind or nature, such as corporations, firms, association, trusts, institution, foundations, or governmental bureaus, departments or agencies.
4. All of the foregoing purposes shall be exercised exclusively charitable and educational purposes in such a manner that the Corporation will qualify as an exempt organization under section 501 (c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.
5. To provide educational and humanitarian services.
6. To raise funds for charitable purposes for the benefit of children and families.

ARTICLE IV. MANNER OF ELECTION:

The Corporation shall have voting Members, who shall be elected (and may be removed) by the voting Members, and who shall have all the rights and privileges of non-voting members.

Directors are elected/appointed as stated in the by-laws.

ARTICLE V. DIRECTORS:

This corporation shall have three (3) Directors. The number of Directors may be increased or diminished from time to time, by the Bylaw of the corporation.


ARTICLE VI. TERM OF EXISTENCE:
