Articles of Incorporation of

mid atlantic beagle federation inc.

This Corporation shall be a nonprofit corporation. This corporation is organized exclusively for pleasure, recreation, and other similar non-profitable purposes, in the context of a social and recreational club as those terms are used in Section 501(c) (7) of the Internal Revenue Code of 1986 or any corresponding provision of any future United States Internal Revenue law. The specific purpose of this organization are to: A family oriented private club providing land for ake registered field trials, and conducting fundraising activities to promote activities of club and subsidize cost to members.

Subject to such limitations and conditions as are or may be prescribed by law, or in the Corporation's Articles of Incorporation or Bylaws, the Corporation shall have all powers which now or hereafter are conferred by law upon a corporation organized for the purposes set forth above, or are necessary or incidental to the powers so conferred, or are conducive to the attainment of the Corporation's purposes.

The Corporation is organized exclusively as a social and recreation club as contemplated by Section 501(c) (7) of the Internal Revenue Code.

Not withstanding any other provision of these articles, the Corporation shall not carry on any other activities not permitted to be carried on: (a) by a corporation exempt from federal income tax under Section 501(c)(7) of the Internal Revenue Code of 1986 (or the corresponding provisions of any future United States Internal Law) (the "Code"); or (b) by a corporation, contributions to which are deductible under Section 170(c)(2) of the Code (or rethe corresponding provision of any future United States Internal Revenue Law).

The Corporation shall not carry on or engage in any political campaign relating to candidacy of any person or otherwise.

No part of the net income of the Corporation shall inure to the benefit of or be distributed to any member, director or officer of the corporation, or any other private individual other than as a legitimate object of the purposes stated in Article Four, but reimbursements for expenditures or the payment of reasonable compensation for services rendered shall not be deemed to be a distribution of income, earnings or principal.

Upon winding up and dissolution of the Corporation, any assets remaining after paying of all debts and obligations shall be distributed to another 501(c) (7) organization or other tax exempt non-profit organization with purposes consistent with the purposes of this Corporation.

All references to sections of the Internal Revenue Code shall include such sections as of the date hereof and the corresponding section of any future federal tax code.
