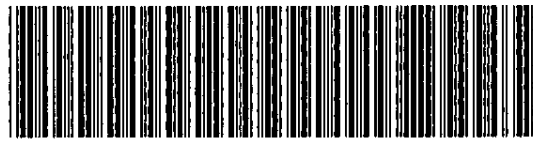

The undersigned incorporator, for the purpose of amending the Articles of a Florida not-for-profit corporation, hereby adopts the following Amendments to the Articles of Incorporation.

**ARTICLE I**

The name of the Corporation is:

IK School of Gymnastics, Inc.

**ARTICLE II**

**ARTICLE III**

The specific purpose for which this corporation is organized is:

The purpose of the corporation is to promote the health and wellbeing of children and the advancement of children's sport activity and physical fitness. The corporation is organized to provide charitable education and opportunities for the disadvantaged/low-income and/or disabled youth of the community, for purposes under Section 501(c)(3) of the Internal Revenue Code and the Laws of the State of Florida governing the activities of charitable or not for profit organizations. Objectives of the corporation include the organization of fitness/sport related classes and activities for children of varied ages, as well as assistance for participation in fitness/sport classes, events, tournaments and competitions, ranging from aid with travel expenses and uniforms to personal training and equipment.

**ARTICLE IV**

Upon the dissolution of the organization/corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not disposed of shall be disposed of by a court of competent jurisdiction in the county in which the principle

office of the organization/corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.


