 The purpose for which the corporation is organized is:
 The purpose for which the corporation is formed shall be exclusively to act as the principal authorized campaign committee for Adam Hasner, candidate for the United States Senate from Florida, as that term is defined in the Federal Election Campaign Act of 1971, as amended (2 U.S.C. ss 431 et seq.). The Corporation is organized as a political organization for the exempt function of influencing or attempting to influence the selection, nomination, election, or appointment of Adam Hasner to the United States Senate, consistent with Section 527 of the Internal Revenue Code of 1986, as amended, and to engage in any and all lawful activities incidental to the foregoing.

ARTICLE IV MANNER OF ELECTION The manner in which the directors are elected and appointed:
 The Initial Board of Directors shall consist of the three (3) persons as forth in Article V, appointed by the Incorporator. Each Director shall hold office until the expiration of the term for which the Director was elected and until the Director's successor has been duly elected and qualified, or until the Director's prior resignation or removal, as provided in the Bylaws duly adopted by the Board of Directors.
