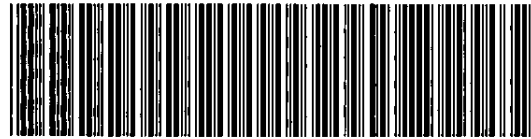

Manner of Election:

The first Board of Directors appointed to constitute and initiate the incorporation of Palm Bay Recreation & Activities Association, Inc. shall consist of five (5) Directors who are members of the Corporation and who shall serve until the annual membership meeting held in February, 2012, or until their successors are elected and qualified. At the annual meeting to be held on the first Monday in February, five directors shall be elected from among the male and female members. Directors chosen by the first ballot naming five members shall be tabulated and the two members getting the most votes shall serve for two years, and the three members getting the next highest votes shall serve for one year. In case of a tie there will be a run-off. Thereafter, the Board shall always consist of five (5) Directors whose term of office will be for two years, with three (3) elected one year and two (2) the next.
