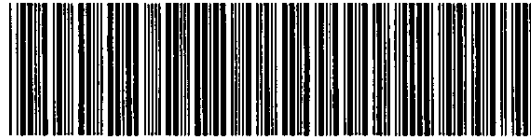

Pursuant to the provisions of section 617.1006, Florida Statutes, this Florida Not for Profit Corporation adopts the following amendments to its Original Articles of Incorporation filed 06/15/2017

ARTICLE I – AMENDMENT TO NAME

NONE: The name of the Corporation is and will remain Street Racing Made Safe Program Inc and it's effective on date is when originally incorporated is June 7,2011

ARTICLE II – PRINCIPAL PLACE OF BUSINESS

The principal place of business and mailing address is 12752 NW 98th Place Hialeah Gardens, Florida 33018

ARTICLE III – PURPOSE

The organization was created as a non profit 501 © 3 as determined by the IRS which came to fruition in 2011 after it's Founder Mario L Ojito's father died as a result of illegal street racing and his best friend suffered a brain injury during a motorcycle accident. Not long after that Mario began thinking of ways to change street racing to a conducive, safe and proper environment taking street racing off the streets, educate them and take them to the tracks. SRMS wants the racers to have the same fun and thrill of racing on the streets so the program safely mimics that as close as possible. Mario also knows his program will continue to improve communities by keeping roads and highways safer.

To Mario it is more of a personal conviction to avoid illegal street racing and the fatalities by educating illegal street racers through a program curriculum that consists of many components that are taught in order for the client to race in a controlled environment. To this day SRMS has taken thousands of people off the streets and to professional tracks across the nation. It is because of the SRMS program and its team of committed former illegal street racers who've educated racing aficionados that continue to save lives while enjoying the thrill and feeling the adrenaline that this sport creates. SRMS statistics show that we have the solution to an "unmet need for Illegal Street racing that has always been frowned upon and which has created positive change by impacting the lives of thousands around the country to change what people once frown upon for many decades"

ACTIVITES IV

1. We will collaborate and partner with various other non profit organizations that align with SRMS integrity and values that can be integrated into institutions of higher education and establish internship programs for those from high school to higher education. We will partner and collaborate with the community and other professionals in their field of expertise local, state and federal agencies and other non-profit organizations that will add to the quality of life and improve the way in which this sport is practiced in a safe and controlled environment where there's a prepped track to prevent skidding, retaining walls separating racing cars, spectators and emergency personnel on standby. A former street racer himself Mario's overarching goal is to eliminate street racing on public roads and get them educated and onto the tracks.
- 2 We will conduct all activities that impact communities at large and for children and youth in an appropriate educational center environment providing prevention and educational care needs for a disadvantaged and underserved communities where youth and young adults live as well as involve their parents.
- 3 We have created, developed, trained and implemented a solid education-prevention curriculum with positive results. We also hold outdoor racer and family activities focused on the drivers and their families. Our outreach program is crucial to youth and families directed at safety and security and serving all communities throughout the nation.
- 4 We have conducted thousands of activities across the country to all of the communities including those with limited resources not limited to the construction of an SRMS educational and prevention compound and center for research. We will partner and implement our curriculum in schools, youth and young adult's medical facilities, family housing, other facilities located in poor and disadvantaged areas. As a non-profit organization we are committed to join in with other community-based organizations to help provide to the poor and needy food, medical supplies and other basic necessities in the event of any natural disaster. We are a team of professionals dedicated to pioneering and embracing the future of street racing. All of our activities include all team members during each race they hold near our core values at heart. Our Values above all are: Integrity, Transparency, Loyalty, Commitment to culture and cause, Passion, Education, Love, Faith and Family

5 To exercise all such power and authority as may be necessary to carry out the purposes above-specified, the purpose of this Corporation being in essence truly religious, educational and charitable. This Corporation is organized exclusively for religious, educational, and charitable purposes as specified under section 501(c) (3) of the Internal Revenue Code, or corresponding section of any future tax code.

6 This Corporation shall not, as a substantial part of its activities, carry out propaganda or otherwise attempt to influence legislation; nor shall it participate or intervene (by publication or distribution of any statement or otherwise) in any political campaign on behalf of any candidate for public office.

7 Except as limited by these Articles of Incorporation or its Bylaws, the Corporation shall have and exercise all rights and powers in furtherance of its purposes as are now or may hereinafter be conferred on not-for-profit corporations under the laws of the State of Florida.

ARTICLE V EXECUTIVE BOARD MEMBERS

The Executive Board will be the founding members shall be called the Executive Board of Directors, the trustees who will have venue but no vote. New members and the manner of their admission shall be prescribed in the Bylaws. The founding members are as follows:

The Officers of the Corporation shall consist of a President, Vice-President, Treasurer, and Secretary and Members of the General Board. The Board of Trustees may elect other officers, as they may deem necessary. The officers will manage all the affairs of the Corporation. The founding members will initially serve as officers until the Board of Trustees officially appoints the officers.

ARTICLE VIII – INCORPORATOR

The incorporator shall remain the same

ARTICLE IX – EFFECTIVE DATE

The effective date for this Amended Article of the Corporation shall be June 15, 2017

ARTICLE X – BOARD OF TRUSTEES

A Board of Trustees shall govern the Corporation. Voting Officers of the Board of Trustees shall not be less than Seven (7). The number of Trustees may be increased or decreased from time to time as prescribed by the Bylaws. The Trustees shall be selected for the terms and in the manner set forth by the Bylaws. The General Board of Directors Member will be known as Street Racing Made Safe Program Inc.'s Governing Board. The founding members will serve as Trustees until the first election or selection of the Board of Trustees. Members called the Executive Board Members will have venue but no voting privileges

ARTICLE XI – POWERS

The Corporation shall have the following powers:

1. All the powers granted to corporations not for profit by section 617 of the Florida Status, and all other further powers that Florida Statutes may grant in the future to such corporations.

2. To acquire, receive, purchase, take by gift, grant, devise, bequest or otherwise, real, personal, and mixed property of every kind and description, whosoever the same may be situated and without limit as to amount, including, without limiting the generality of the foregoing, money, lands, buildings, mortgages, shares, stocks, or to other securities of any donor; and to hold, invest, reinvest, use, mortgage, pledge, sell, lease, assign, give, exchange, transfer or otherwise, dispose of the same at pleasure.

3. To borrow money from any person, firm, or corporation and to issue notes or obligations of the corporation from time to time for any of the purposes of the Corporation and secure the same by lawful means; to enter into, make, perform and carry out contracts of any kind or nature for any of the objects or purposes of Street Racing Made Safe Programs, Inc without limit as to amount.

4. To do all and everything necessary, suitable and proper for the accomplishment of any of the purposes or the attainment of any of the purposes or the furtherance of any of the powers herein set forth and to the same extent as natural persons might or could do, either alone or through the agency of other corporations, organizations, foundations, institutions, governmental bodies or individuals, and to do every other act or acts, thing or things, incidental or appurtenance to or growing out of or connected with the aforesaid purposes or any part or parts thereof, and to do all things not forbidden by the laws of the United States, State of Florida, the, or any state where this Corporation is duly qualified, and with all the powers conferred upon corporations by the laws of said states.

5. Nothing herein contained shall be deemed to authorize the Corporation to engage in any activity or activities, which are contrary to the Florida law on corporations not for profit. The Corporation shall not conduct or carry on any activities not permitted to be conducted or carried on by an organization exempt from taxation under Section 501(c)(3) of the code, or by an organization contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code of 1986, as amended.

6. To acquire, hold, operate and dispose of any and all privileges, rights, franchises and concessions, and to buy, lease, sell, mortgage and exchange any and all real and personal property which may be necessary, advantageous or proper in the conduct of its business; to purchase equipment and supplies and to do all things necessary to carry out the purposes of the Street Race Made Safe Program Inc. and the Underserved and Underprivileged communities

7. To receive gifts, legacies, and donations from any source and to make gifts, donations, and appropriations from any and all of its resources from time to time to carry out the purposes of Street Race Made Safe Program Inc.

8. Said organization is organized exclusively for charitable, religious, educational, and scientific purposes, including for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code. Charitable purposes in its generally accepted legal sense and includes relief of the poor, the distressed, or the underprivileged; advancement of medical conditions, advancement of religion; advancement of education or science; erecting or maintaining public buildings, monuments, or works; lessening the burdens of government; lessening neighborhood tensions; eliminating prejudice and discrimination; defending human and civil rights secured by law; and combating community deterioration and juvenile delinquency.

ARTICLE XII - LIMITATION ON ACTIVITIES

No part of the net earning of the Corporation shall inure to the benefit of, or be distributable to, any Member, Trustee, or Officer of the Corporation or any other private individual (except that reasonable compensation may be paid for services rendered to or for the Corporation affecting one or more of its purposes), and no Member, Trustee, or Officer of the Corporation, or any other private individual, shall be entitled to share in the distribution of any of the corporate assets on dissolution of the Corporation.

ARTICLE XII – DISSOLUTION

Upon the dissolution of the Corporation, the Members of the Corporation shall, after paying or making provisions for the payment of all of the liabilities of the Corporation, dispose of all of the assets of the Corporations to an organization exempt from taxation under Section 501(c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to state or local government, for a public purpose.

ARTICLE XIII – INDEMNIFICATION

The Corporation shall indemnify any Trustee or Officer or former Trustee or Officer for expenses and costs (including attorney's fees) actually and necessarily incurred thereby in connection with any claim asserted against that person, by action or otherwise, by reason of such person being or having been such Trustee or Officer, except in relations to matters to which such person shall have been guilty of gross negligence or willful malice with respect to the matter in which indemnity is sought. By order of the Trustees, the Corporation may, under comparable terms and limitations indemnify employees and agents of the Corporation on behalf of the Corporation.


ARTICLE XIV – BYLAWS

The Board of Trustees shall provide such Bylaws for the conduct of its business and the carrying out of its purpose as it may be deemed necessary. The Board of Trustees at any regular or special meeting of the Board of Trustees may amend the Bylaws by a two-thirds majority vote of all active Trustees.

ARTICLE XV – AMENDMENT TO ARTICLES

These Amended Articles of Incorporation may be amended at a regular meeting of the Board of Trustees by a two-third majority vote of all active Trustees, provided that such amendment does not contravene the purposes of the Corporation as set out in these Articles of Incorporation and would not adversely affect its status as an organization qualifying under Section 501(c) (3) of the Internal Revenue Code.

The Board of Trustees adopted these amended articles and the number of votes cast for the original articles was sufficient for approval. An original copy of these articles will reside with the Secretary of State Division of Corporations.
