In Compliance with Chapter 617, F.S., (Not for Profit)

## Article I – Name of Corporation

The name of the Corporation shall be - IT'S YES! Performing Arts Institute, Inc.

## Article 2 – Principal Place of Business

## Article 3 – Purpose

Is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501 © (3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

## Article 4 – Manner of Election

The manner in which the officers and directors are elected and appointed shall be stated in the bylaws.

## **Article 6 – Registered Office and Registered Agent**

## **Article 8 – No Private Inurement**

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, directors or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article 3 hereof.

## **Article 9 – Lobbying and Political Campaigns**

No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501 (c) (3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170 (c) (2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

## Article 10 – Dissolution

Upon the dissolution of the corporation, assets shall be distributed for one of more exempt purposes within the meaning of section 501 © (3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes. Having been named as registered agent to accept service of process for - IT'S YES! Performing Arts Institute , a Florida Not For Profit Corporation, at the place designated in this certificated. I am familiar with and accept the appointment as registered agent and agree to act in this capacity.
