Statement of Purpose

of

The Tampa Repertory Theatre, Inc. (Attachment to Articles of Incorporation)

The corporation is organized exclusively for the charitable, religious, educational, and scientific purposes under section 501(c)3) of the Internal Revenue Code, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

More specifically, the purpose for which the corporation is organized is:

- a. To produce stage plays, and related cultural and educational events, from the full range of theater history, for the artistic and educational enrichment of the people of Tampa Bay.
- b. To provide, through workshops and open classes, continuing educational and development opportunities for local theatre artists.
- c. To engage in educational outreach, through performance, performance opportunities, and classes, both for children and adults in the local community.

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to, its members, directors, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in the furtherance of the purposes set forth in this article. Notwithstanding any other provisions of these articles, this organization shall not carry on any other activities not permitted to be carried on by an organization exempt from Federal Income Tax under IRC 501(c)3 or the corresponding provision of any future United States Internal Revenue law.
