# **Articles of Incorporation**

# IGLESIA BAUTISTA EBENEZER DE NAPLES, FLORIDA, INC.

## ARTICLE I NAME

The name of this corporation shall be Iglesia Bautista Ebenezer de Naples, Florida Inc.

## ARTICLE II PRINCIPAL OFFICE

The principal office and mailing address shall be located at 3805 The Lord's Way, Naples, Florida 34114, in Collier County, Florida.

## **ARTICLE III PURPOSE**

The purpose of this corporation shall be as follows:

To teach about, train leaders to serve and promote the spiritual needs of the Hispanic community through the teaching of the Bible and the worship of God.

# ARTICLE VI REGISTERED AGENT

# **ARTICLE VIII**

This corporation shall have all the powers and authority granted to it under Chapter 617, Florida Statutes.

## **ARTICLE IX**

In the event of dissolution, the residual assets of the corporation shall be transferred to one or more organizations which themselves are exempt as organizations under 501 (c)3 of the Internal Revenue Code or corresponding section(s) of any prior or future internal Revenue Code. Further, it is the desire of the corporation that such assets be distributed to those organizations which have substantially similar purposes as those of Iglesia Bautista Ebenezer de Naples, Florida, Inc.

#### **ARTICLE X**

Iglesia Bautista Ebenezer de Naples, Florida, Inc. is organized exclusively for charitable, educational and/or scientific purposes under 501(c)3.

No part of the net earnings of the organization shall inure to the benefit of, or be distributable to its members, trustees, officers or other private persons, except that the organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof. No substantial part of the activities of the organization shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the organization shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of this document, Iglesia Bautista Ebenezer de Naples, Florida, Inc. shall not carry on any other activities not permitted to be carried on by an organization exempt from federal income tax under 501c3 of the Internal Revenue Code, or corresponding section of any future federal tax code, or by an organization, contributions to which are deductible under 170c2 of the Internal Revenue Code, or corresponding section of any future federal tax code.

Having been named as registered agent to accept service of process for the above state corporation at the place designated in this certificate, I am familiar with and accept the appointment as registered agent and agree to act in this capacity.
