THE PURPOSE FOR WHICH THE ORGANIZATION IS BEING ORGANIZED IS:

- A. TO PROMOTE SOCCER TOURNAMENTS AND GAMES FOR CHILDREN AND ADULTS IN THE PALM BEACH COUNTY AREA.
- B. TO CONDUCT AND OR SUPPORT PROJECTS TO AID IN PROVIDING SOCCER TOURNAMENTS AND GAMES FOR PALM BEACH COUNTY RESIDENTS.

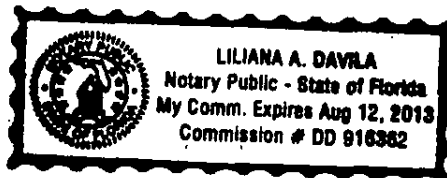
