I. **Name:** The name of this corporation is: **UNITED STATES ARGENTINA CHAMBER OF COMMERCE, INC.**

II. **Duration:** The period of its duration is in perpetuity.

III. **Corporate Nature:** This is a nonprofit corporation organized solely for charitable purposes pursuant to the Florida Not for Profit Corporation Act (Chapter 617, Florida Statutes.)

IV. **Purpose:** The purpose of this corporation is to promote trade between Argentina and the United States between individuals and entities, to establish offices in both countries to provide counseling, advice, non financial support, and other such matters as will qualify it as an exempt organization under Section 503(c)(3) of the Internal Revenue Code of 1954 or corresponding provisions of any subsequent federal tax laws, including, for such purposes, the making of distributions to organizations qualifying as tax exempt organizations under law. Notwithstanding anything herein to the contrary, the Corporation shall exercise only such powers as are in furtherance of the exempt purposes of organizations set forth in Section 503(c)(3) of the Internal revenues Code of 1954 and the Regulations thereunder as the same now exist or as they may hereinafter be amended from time to time.
