#### A FLORIDA NOT-FOR-PROFIT CORPORATION

The undersigned, acting as the incorporators of a not for profit corporation under the Florida

Not For Profit Corporation Act, as set forth in Chapter 617 of the Florida Statutes, as amended,
adopts the following Articles of Incorporation for such Corporation:

#### **ARTICLE I: NAME**

The name of the corporation shall be: Youth Advancement Coalition, Inc., hereinafter referred to as the "Corporation".

#### **ARTICLE II: PRINCIPAL OFFICE AND MAILING ADDRESS**

The address of the principal office of the Corporation is 941 NW 33<sup>rd</sup> Dr., Lauderhill, FL 33311, and the mailing address of the Corporation is the same, 941 NW 33<sup>rd</sup> Dr., Lauderhill, FL 33311.

#### **ARTICLE III: PURPOSE**

The Corporation is organized and operated exclusively for charitable and educational purposes within the meaning of Section 501 (c) (3) of the Internal Revenue Code of 1986, as amended. Notwithstanding any other provision of these Articles, the Corporation shall not carry on any other activities not permitted to be carried on (i) by a corporation exempt from federal income tax under Section 501 (c) (3) of the Internal Revenue Code of 1986, (or the corresponding provision of any future United States Internal Revenue Law), or (ii) by a corporation, contributions to which are deductible under Section 170 (c) (2) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue Law).

#### **ARTICLE IV: MANNER OF ELECTION**

The number of directors to be elected and appointed after the first Board of Directors, and the manner of their appointment shall be fixed by the bylaws of this corporation, and the determination thereof shall not require any amendment to these Articles of Incorporation. It being the intentions of the founding parties that the bylaws to be adopted, rather than these Articles of Incorporation shall, after the first Board of Directors, govern both the number of directors and the manner of their election and appointment to the said Board of Directors.

#### **ARTICLE VI: INITIAL REGISTERED AGENT AND STREET ADDRESS**

#### ARTICLE VII: INCORPORATORS

The Incorporator of Youth Advancement Coalition Inc. is Andrew Bush of 941 N.W. 33<sup>rd</sup> Dr., Lauderhill, FL 33311.

#### **ARTICLE VIII: DURATION**

The period of duration of the Corporation shall be perpetual unless dissolved according to law.

#### **ARTICLE IX: DISTRIBUTION OF ASSETS UPON DISSOLUTION**

The property of this corporation is irrevocably dedicated to charitable and educational purposes and no part of the net income or assets of this corporation shall ever inure to the benefit of any director, officer, or member thereof or to the benefit of any private person. Upon dissolution or winding up of the corporation, its assets remaining after payment, or provision for payment, of all debts and liabilities of this corporation shall be distributed to a nonprofit fund, foundation or corporation which is organized and operated exclusively for charitable and educational purposes and which has established its tax exempt status under Section 501 (c) (3) of the Internal Revenue Code.

#### **ARTICLE X: AMENDMENTS**

These Articles of Incorporation may be amended at any regular or special meeting of the Board of Directors by a majority vote of those present; provided that notice of the intention to submit amendments shall have been given as provided by the bylaws.

#### **ARTICLE XI: RESTRICTIONS ON ACTIVITIES**

No substantial part of the activities of this corporation shall consist of the carrying on of propaganda or otherwise attempting to influence legislation, nor shall this corporation participate in or intervene in (including the publishing or distributing of statements) any political campaign on behalf of (or in opposition to) any candidate for public office.

#### **ARTICLE XII: MEMBERSHIP**

The corporation shall be a membership organization composed of those persons hereinafter listed as the initial Board of Directors and all other persons or organizations elected/selected for membership as provided in the bylaws.

#### **ARTICLE XIII: LIABILITY LIMITATION**
