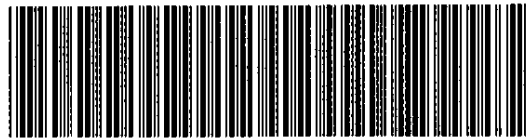



Articles of Incorporation

In compliance with Chapter 617, F.S., (Not for Profit)

Article I – Name

The name of the corporation shall be: Harvest Road Ministries, Inc.

Article II – Principal Office

2658 N Biscayne Drive
North Port, FL 34291

Article III – Purpose

The purpose of this corporation will be to conduct charitable activities related to the training, supporting, ordaining and sending of pastors and missionaries, as well as the creating, supporting and associating of churches.

Article IV – Manner of Election

Directors will be appointed and elected in conformance with the bylaws of the corporation by the sitting board members.

Article V – Distribution of Earnings and Dissolution of Corporation

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Third hereof.

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.
