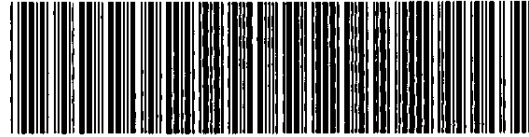

Articles of Incorporation of

A Florida Nonprofit Corporation

Pursuant to the laws of the State of Florida, the undersigned incorporator adopts the following Articles of Incorporation to create a non-profit corporation:

First: The name of the Corporation shall be The Excellent Trenchcoat Society, Inc.
