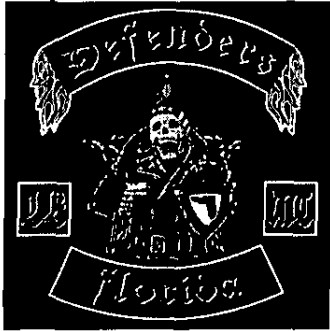

In compliance with Chapter 617, F.S., (Not for Profit / 501(c)7)

ARTICLE I: NAME

The name of the corporation shall be:


ARTICLE VIII: OWNERSHIP




