### Article III.      Specific Purpose

- This corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in compliance with sections 501 (c)(3) and 170 (c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

### Section 1:      Introduction

- This corporation was organized exclusively for the purpose of providing religious, charitable, and educational services to the English and Spanish speaking communities, where they are greatly lacking. Although these communities have had identified a large portion of people as being uneducated and unproductive, it isn't enough to simply be aware of this information and then try to correct the problem without further investigation. The reasons why such needs exist must be identified in order to meet said needs. This corporation believes it is due to the development of codependency as a result of societal institutionalism. In addition, the Spanish speaking community tends to isolate themselves by speaking only Spanish at home, in the community amongst themselves, and by allowing their children to participate in only/primarily Spanish speaking classes at school. As a result, productivity and prosperity are hindered greatly or are impossible to obtain. The inevitable consequence is a large population of emotionally unstable, uneducated, unproductive, unmotivated, and codependent people who may be in need of state assistance, who may be alcohol and drug dependent, unemployed, involved with criminal activity, and so forth (Comer, 2001; Noe, 2005).

### Section 2:      Vision

- Due to the overwhelming needs, it is the **vision** of this corporation to enhance the lives, ensure success, and encourage productivity and prosperity in the English and Spanish

speaking communities. This corporation intends to altogether stop the negative unproductive cycle, or at the least, greatly hinder the perpetuation of it (Comer, 2001; Noe, 2005).

### **Section 3:**                    **Mission**

- In order to respond to the aforementioned needs of the English and Spanish speaking communities and accomplish the vision, it is the ***mission*** of this corporation to establish the following bilingual Council, Church, and Community Outreach, with a Christian Foundation, Military Structure, Montessori Curriculum, and Therapeutic Setting, although the following list is not limited to such (**ALL** proceeds go into the organization in compliance with sections 501 (c)(3) and 170 (c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code):

○ Council

- The purpose of the council is to ensure that the religious, charitable, and educational services are provided to the public by way of the Church and Community Outreach, in accordance with their job descriptions, by keeping critical incident logs and conducting performance evaluations on a regular basis.
- The Council is the sole controlling entity of Like the Days of Noah, Incorporated Council, Church, and Community Outreach Faith-Based Doctrine of Christ Jesus Non-Profit Charitable Organization. The Council Board of Directors is in direct charge of the Council, Church, and Community Outreach.

○ Church

- This corporation considers the “Church” to be the body of Christ in accordance with the Holy Bible, and the place of worship is the building where the Church congregates.
- The purpose of the Church is to ensure that the religious, charitable, and educational services are provided to the public by way of conducting itself in accordance with its job description, by keeping critical incident logs and conducting performance evaluations on a regular basis.
- The Church answers directly to the Council of Like the Days of Noah, Incorporated Council, Church, and Community Outreach Faith-Based Doctrine of Christ Jesus Non-Profit Charitable Organization.
- The Church provides the following Ministries, and it is limited to such in accordance with the Holy Bible, for the equipping of the saints for the work of service to the building up of the body of Christ Jesus, by edification, which means to instruct and improve morals, exhortation, which means to urge, advise, or warn earnestly, and consolation, which means to soothe grief with comfort.

- Pastoral Ministry
    - ❖ The purpose of the Pastor is to be used by God as the Shepherd of the flock, by winning souls for Christ Jesus, and guiding them on the victorious track of living a holy life in Christ Jesus.
  - Prophetic Ministry
    - ❖ The purpose of the Prophet is to be used by God to talk to his people in guide them on the victorious track of living a holy life in Christ Jesus.
  - Teaching Ministry
    - ❖ The purpose of the teacher is to be used by God to teach the Gospel in order to win souls for Christ Jesus, and guide them on the victorious track of living a holy life in Christ Jesus.
  - Evangelism Ministry
    - ❖ The purpose of the Evangelist is to be used by God to preach the Gospel in order to win souls for Christ Jesus, and guide them on the victorious track of living a holy life in Christ Jesus.

  - ❖ A program for the purpose of seeking and obtaining funding to fund the work of the Council, Church, and Community Outreach in general.
- Specials Programs
  - ❖ *Programs for the purpose of catering to the special needs of the Church members by way of, although it is not limited to such, Holidays, celebrations, weddings, baptisms, and funerals.*
- Community Outreach
  - The purpose of the Community Outreach is to ensure that the religious, charitable, and educational services are provided to the public by way of conducting itself in accordance with its job description, by keeping critical incident logs and conducting performance evaluations on a regular basis.
  - The Community Outreach answers directly to the Council of Like the Days of Noah, Incorporated Council, Church, and Community Outreach Faith-Based Doctrine of Christ Jesus Non-Profit Charitable Organization.
  - The Community Outreach provides the following Programs, for the equipping of the saints for the work of service to the building up of the body of Christ Jesus, by edification, which means to instruct and improve morals, exhortation, which means to urge, advise, or warn earnestly, and consolation, which means to soothe grief with comfort.
  - Youth and Family Therapeutic Mentor Center
    - *Typical mentor programs do not provide hands on training for youth and families as a whole in order to modify and manage behavior and they focus primarily on the youth not the family unit as a whole, and that is where they are lacking as a program. The purpose of this program is to provide therapeutic mentoring to biological, foster, and adoptive youth and their families. Including families is vital to the success of the family as a whole. This program is based on a combination of cognitive and behavioral psychology, and Holly Perez's Cognition and Behavior Modification and Management Plan. By providing such mentoring it is the intention of this program to create emotionally stable youth and family units. This is the program that keeps families together, and allows stable family units (Comer, 2001; Monte & Sollod, 2003; Noe, 2005; Perez, 2006).*

- Christian Roller Skating Rink
  - The purpose of this program is to provide a fun Christian activity for families. One void of alcohol, cigarette smoke, violence, foul language, and non-Christian music. It is the intention of this program to meet the needs, both material and spiritual. As always, **ALL** proceeds go into the organization/God's work in compliance with sections 501 (c)(3) and 170 (c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code (Comer, 2001; Monte & Sollod, 2003; Montessori, 1912; Noe, 2005; Perez, 2006).
- Christian Dinner Show
  - Typical dinner shows are profit businesses and do not focus on the Holy Bible. The purpose of this program is to provide a public restaurant where people are able to enjoy dinner and theatrical entertainment simultaneously, in an environment suitable for all ages. The theatrical entertainment is based on Biblical themes. Again, **ALL** proceeds go into the organization/God's work in compliance with sections 501 (c)(3) and 170 (c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code (Comer, 2001; Noe, 2005).
- Private Christian School
  - Typical private Christian schools do not provide sufficient special educational and psychological curriculums, assistance, and they do not provide technical career training which is vital to successful employment just after graduation, while continuing their education at a higher education institution, and that is where they are lacking as a program. The purpose of this program is to provide a Christian foundation, military structure, technical career training, and an educational curriculum based on a unique combination of cognitive and behavioral psychology, Maria Montessori, and Holly Perez's Cognition and Behavior Modification and Management Plan. This school provides education for Pre-K, Elementary, Junior High, and High School. It is the intention of this program to ensure happy, peaceful, independent, emotionally stable, productive, successful, adult citizens in society (Comer, 2001; Monte & Sollod, 2003; Montessori, 1912; Noe, 2005; Perez, 2006).
- Therapeutic Vacation Resort
  - There is no typical therapeutic vacation resort in the area which caters to the needs of foster, adoptive, and biological youth and their families. The purpose of this program is to provide therapeutic vacations/getaways to foster and adoptive families. All amenities and therapeutic workshops are included. Childcare activities for foster, adoptive, and biological children are also included. The childcare activities are divided up into foster, adoptive, and



biological groups to cater to the specific needs of each group of children. This provides a break for parents and children, as well as some exciting fun time for the children. The childcare activity staff is trained to work with the therapeutic needs of the foster, adoptive, and biological children. The workshops cater to the needs of the parents. This program is based on a combination of cognitive and behavioral psychology, and Holly Perez's Cognition and Behavior Modification and Management Plan. By providing such a vacation resort it is the intention of this program to promote emotional stability. This is the program that keeps families together, and allows for refreshed, reenergized, and stable family units. Once again, **ALL** proceeds go into the organization/God's work in compliance with sections 501 (c)(3) and 170 (c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code (Comer, 2001; Monte & Sollod, 2003; Montessori, 1912; Noe, 2005; Perez, 2006).

- Christian Campground
  - The purpose of this program is to provide a fun Christian activity for families. One void of alcohol, cigarette smoke, violence, and foul language. It is the intention of this program to meet the needs, both material and spiritual. As always, **ALL** proceeds go into the organization/God's work in compliance with sections 501 (c)(3) and 170 (c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code (Comer, 2001; Monte & Sollod, 2003; Montessori, 1912; Noe, 2005; Perez, 2006).
- Youth and Family Counseling Center
  - Typical Counseling programs do not provide hands on training for youth and families as a whole in order to modify and manage behavior, and that is where they are lacking as a program. The purpose of this program is to provide individual and group counseling to individuals and families. The program is based on a combination of cognitive and behavioral psychology, and Holly Perez's Cognition and Behavior Modification and Management Plan. By providing such counseling it is the intention of this program to create emotionally stable individuals and families. This is the program that keeps families together, and allows for stable family units (Comer, 2001; Monte & Sollod, 2003; Noe, 2005; Perez, 2006).
- Therapeutic Group Home Center, Therapeutic Residential Center, Intensive Psychiatric Facility, and Therapeutic Special Education School
  - Typical therapeutic group homes, therapeutic residential programs, intensive psychiatric facilities, and special education school programs do not provide hands on training for youth and families as a whole in order to modify and manage behavior, and they focus primarily on the youth not the family unit as a whole, and that is where they are lacking as a program. The purpose of this

program is to provide care to biological, foster, and adoptive youth and families in need. Including families is vital to the success of the family unit. In addition, the therapeutic special education school is provided to the youth in said programs, and to the youth in the community who need such a setting in order to be successful. This program is for those youth who would normally fall through the cracks and end up the “degenerates” of our society, those whose parents can’t afford to send them to a program to get the help that they need, those who are just under the eligibility requirements for a therapeutic program, and those whom nobody wants because they simply assume that they are unmotivated and disrespectful kids. This program, as a whole, provides a Christian foundation, military structure, technical career training, and an educational curriculum based on a unique combination of cognitive and behavioral psychology, Maria Montessori, and Holly Perez’s Cognition and Behavior Modification and Management Plan. It is the intention of this program to ensure happy, peaceful, independent, emotionally stable, productive, successful, adult citizens in society regardless of their disabilities. By providing such a facility and school it is the intention of this program to create emotionally stable youth and family units. This is the program that keeps families together, and allows for stable family units (Comer, 2001; Monte & Sollod, 2003; Montessori, 1912; Noe, 2005; Perez, 2006).

- Christian Radio, Television, and Internet Stations
  - The purpose of this program is to preach the Gospel to all creation via the radio, television, and internet by being a 24/7 resource to the community, including, but not limited to, those individuals in hospitals, convalescent homes, rehabilitation centers, and incarcerated. It is the intention of this program to meet the needs, both material and spiritual, of the community which sends a loud message that says as long as you have life you have hope. Notwithstanding, **ALL** proceeds go into the organization/God’s work in compliance with sections 501 (c)(3) and 170 (c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code (Comer, 2001; Monte & Sollod, 2003; Montessori, 1912; Noe, 2005; Perez, 2006).
- Adult Education Center
  - Typical Adult Education programs do not cater to special educational and psychological needs and that is where they are lacking as a program. The purpose of this program is to provide educational classes which are psychology-based (catering to individual needs), although the following list is not limited to such: Parenting, marriage and family, driver’s license, English as a second language, GED, ASVAB, SAT, GRE, life skills, racism, prejudice, and diversity training, college/university homework assistance, technical career training, resume writing and interviews, Immigration and US residency and citizenship, Spanish as a second language, and computers (Comer, 2001; Noe, 2005).

- In addition to educational classes, it is vital to assist the student in applying what he or she has learned to his or her life and/or job. This will create an independent and productive workforce. The church can obtain a job for someone, but, that person will not be successful unless he or she has the tools necessary to be a productive employee. Therefore, making the adult student employable is a necessary part of their education. It is the intention of this program to turn out individuals ready for the workforce or to continue their education at a higher education institution (Comer, 2001; Noe, 2005).
- Food Bank
  - The purpose is to provide free non-prepared meals/food to the community as a supplement. It is the intention of this program to provide for hungry individuals and families in need so that parents and their children can focus on their education and employability not when they are going to get their next meal. This will take the burden off of the parents, government, and society by providing nutrition to those in need (Comer, 2001; Montessori, 1912; Noe, 2005).
- Soup Kitchen
  - The purpose is to provide free prepared breakfast, lunch, and dinner to the community. It is the intention of this program to provide for hungry individuals and families in need so that parents and their children can focus on their education and employability not when they are going to get their next meal. This will take the burden off of the parents, government, and society by providing nutrition to those in need (Comer, 2001; Montessori, 1912; Noe, 2005).
- Secondhand Goods
  - The purpose is to provide free material goods to the community. It is the intention of this program to provide for individuals and families in need so that parents and their children can focus on their education and employability not whether or not they have a table to do their homework on, or a bed to sleep in at night. This will take the burden off of the parents, government, and society by providing to those in need (Comer, 2001; Montessori, 1912; Noe, 2005).
- Certified English and Spanish Translators
  - Typical certified translators are expensive, not expedient, and not 100% accurate. The purpose of this program is to provide certified translations of English and Spanish documents to the community. It is the intention of this program to ensure the accuracy of translations, which will affect the efficiency

of processing said documents, and eradicate red tape (Comer, 2001; Noe, 2005).

- Social Services Consulting and Assistance
  - Typical consulting programs are not discrete, do not have accurate answers, are unprofessional, point people in the wrong direction, and do not assist in filling out the necessary forms needed. The purpose of this program is to provide free consultations and assistance regarding social service needs and filling out applicable forms. It is the intention of this program to provide social services consultations so that individuals and families find the necessary help that they need, and to assist such individuals in filling out the applicable forms in order to obtain such help, so that they can focus on their education and employability. This will take the burden off of the, parents, government, and society by providing to those in need (Comer, 2001; Montessori, 1912; Noe, 2005).
- Immigration Consulting and Assistance
  - The purpose of this program is to provide free consultations and assistance regarding immigration processes and filling out applicable forms. It is the intention of this program to provide free immigration consultations so that individuals and their families find the necessary help they need, and to assist such individuals in filling out the applicable forms, so that they can focus on their education and employability. This will take the burden off of the parents, government, and society by providing to those in need (Comer, 2001; Noe, 2005).

**Article IX. Dissolution Clause**

- In compliance with section 501 (c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, upon dissolution of this corporation any and all assets will be completely distributed, by **random assignment**, to nonprofit charitable organizations in the community.

**Article X. Net Earnings**

- In accordance with the purposes set forth in Article III herein, and in accordance with section 501 (c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, this corporation shall not distribute any net earnings to any Board

of Directors/Officers or private persons, except reasonable compensation for services rendered.

#### **Article XI.            Conflict of Interest Clause**

- This organization does not consider it a conflict of interest to be Council and Church members/employees, and Community Outreach employees simultaneously, because they have a vested interest in all three due to the fact that the organization is family owned and operated, and all three have specific organizational job descriptions which accounts for any conflict of interest. Furthermore, the organization is organized in such a way as to account for a conflict of interest which ensures, to the best of its ability, that there is no potential to undermine self-interest verses professional interest.

#### **Article XII.           Statement of Faith**

***This corporation believes in the following:***

- *The Doctrine of Christ Jesus found in the Holy Bible, therefore, we live according to Grace (New Testament) not the Law (Old Testament).*

#### **Section 1:                Three Persons in One Godhead (Holy Bible, Colossians 2:9)**

##### **➤ Godhead (Theotēs)**

- The Godhead is the unity of the Father, the Son, and the Holy Spirit are three persons in one Godhead (Holy Bible, Matthew 28:19).
  - Father
    - God has a great many names, but the more commonly used name in the Holy Bible is Jehovah, therefore, herein when referring to God it is implied Jehovah God. He is the Father and first person of the three persons of the Godhead. God is the Alpha and the Omega. No one has seen God (Holy Bible, Romans 1:20).
  - Son
    - The Son has a great many names as well, but, the more commonly used name in the New Testament is Christ Jesus of Nazareth, therefore, herein when referring to the Son it is implied Christ Jesus. He is the Son and the second person of the three persons of the Godhead. Christ Jesus is the Savior of the World. He is the only person an individual can go through to get to the Father. Christ Jesus has been seen, continues to be seen, and will be seen at his coming (Holy Bible, John 3:16).

- Holy Spirit
  - The Holy Spirit has a number of names and symbols, but, the more commonly used name in the Holy Bible is the Holy Spirit of God. He is the power, authority, and works and third person of the three persons of the Godhead. The Holy Spirit has been seen and continues to be seen (Holy Bible, John 15:26).

**Section 2:                    *Salvation in Christ Jesus (Holy Bible, John 3:16-18)***

➤ **Physical Act of Asking for Salvation**

- We all have all sinned and come short of the glory of God, therefore, it takes an outward physical act of spoken prayer, by faith in Christ Jesus, to repent of all sin and ask for salvation, which represents the desire of the individual to kill the sinful flesh and live a holy life by the Spirit of God.

➤ **Spiritual Act of Receiving Salvation**

- After the outward physical act of spoken prayer for salvation, Christ Jesus washes all sin away with his blood that was shed on the cross (by the crown of thorns, the whip, and by being pierced with the nails and the spear) by the Holy Spirit of God, and then the sin is nailed to the cross forever (not in the depths of the sea because that was according to the law (Old Testament), now it is according to the Grace (New Testament)). Christ Jesus paid the debt of sin so that humanity could live an everlasting life in Christ Jesus free from sin.

**Section 3:                    *Water Baptism of Christ Jesus (Holy Bible, Mark 16:16)***

➤ **Symbolic Act of Washing of Water by the Word**

- An outward physical act of baptism which represents the desire of the individual to kill the sinful flesh and live a holy life by the Spirit of God. The act of immersing the body in water is a symbol of the death of Christ Jesus, and rising out of the immersion of water is a symbol of the resurrection of Christ Jesus and a holy life by the Spirit of God in Christ Jesus.

➤ **Spiritual Act of Washing of Water by the Word**

- An inward spiritual act of baptism which represents the desire of the individual to kill the sinful flesh and live by the Spirit of God. The water that was shed, when Christ Jesus was pierced with the spear while he was on the cross, is the water that baptizes the individual through the washing of water by the Word/Christ Jesus.

**Section 4:                    *Holy Spirit Baptism of God (Holy Bible, Acts 2:1-4)***

- To be filled overflowing with the Holy Spirit and power of God. To be used by God with the gifts of the Spirit of God for the building up of the body of Christ Jesus. However, this is only possible by first pursuing Love/God.

**Section 5:                   Biblical Instruction (Holy Bible, Matthew 7:7-8)**

- To study the Bible/Word/Christ Jesus independently in private and at church, and in a institute, college, or university. The individual builds a relationship with God through Christ Jesus when drawing closer to him by studying the Bible/Word/Christ Jesus, and Christ Jesus in return draws closer to the individual. The result of studying the Bible/Word/Christ Jesus with your heart is the manifestation of the anointing power and authority of the Bible/Word/Christ Jesus (sword of the spirit of God, which is Christ Jesus) in public through the individual.

**Section 6:                   Daily Christian Sanctification Walk (Holy Bible, Romans 12:1-2)**

- Love God with all of your heart, soul, and mind (having no other gods before God). Pursue Love/God and the Christian will love their neighbors as they love themselves. This means that Christians will lay down their lives everyone else. The Christian walks in sanctification daily if he/she allows God to work the fruit of the Spirit in him/her through obedience in submitting to Christ Jesus.
- Christian Relationships are victorious if they are sanctified daily (build a relationship with God through Christ Jesus). It is all about LOVE. To pursue Love is to pursue God. Without that relationship with God we are resounding symbols. The following are five key relationships in hierarchical order (Holy Bible, Ephesians 5:22-33; 6:1-9):
  - Christ with the Individual/Born Again Christian (one Spirit). Christ laid down his life (ultimate LOVE) for humanity and in return the Born Again Christian respects (submits) God. This is the first and foremost relationship there is. The relationship a Christian has with God through Christ Jesus determines the victory of said relationship and the following four relationships. In other words, Christians must walk in sanctification daily in order to live a victorious life in each relationship. If not, the Christian does not live in victory and all of the other relationships are negatively affected.
  - Husbands with their Wives (one Flesh). Husbands must lay down their lives (Love) for their wives and wives must in return respect (Submit) their husbands.
  - Parents with their Children (one Family). Parents must lay down their lives (Love) for their children and in return children respect (Submit) their parents.
  - Pastors with their Church (one Body of Christ Jesus). The Pastor must lay down his/her life (Love) for the assembly and in return the assembly respect (Submit) the pastor.



- Born Again Christians with the World/Lost souls (one Doctrine of Christ Jesus). Christians must lay down their lives (Love) for the world/Lost Souls and if those individuals come to Christ Jesus, in return they respect (Submit) God.

#### ➤ **Applications**

- The spiritual act of worshiping God (which kills the flesh/sin), instead of the fleshly act of worshiping the devil, is to present to God our bodies, daily, as a Living Sacrifice; Holy and Pleasing to God (Holy Bible, Romans 12:1-2):
  - Christians must give their undivided attention to God in the Spirit of God daily as individuals, couples, families, churches, and ministries. The following three components are necessary for the process of sanctification, which is, spending time with God in order to build a relationship with him, and it is necessary to do all three simultaneously (Holy Bible, Matthew 7:7-12):
    - Fast = Knock and Door Will be Opened. This means to come into God's presence to receive spiritual food.
    - Bible = Seek and You Will Find. This means to study the Bible/Word/Christ Jesus and you will receive understanding of it by spiritually discerning/understanding the Bible/Word/Christ Jesus.
    - Prayer = Ask and You Shall Receive. This means to communicate, by faith, with God in the name of Christ Jesus and what you ask for you will receive, in accordance with the Bible (faith moves the hand of God).

#### ➤ **Results**

- The Character of Christ Jesus is the first result of sanctification (Holy Bible, Ephesians 4:23-27; 5:1-2).
  - The Christian obtains the character of Christ Jesus by being renewed in the Spirit of the mind by the Holy Spirit of God. It is only then that the Christian has the mind of Christ (Holy Bible, Ephesians 4:23-27).
    - The Christian character is to live sinless, and to be humble, meek, quick to listen, slow to talk, and slow to get angry (Holy Bible, James 1:19-22).
  - The Christian also obtains the character of Christ Jesus by being filled with the Fruit of the Spirit of God (Holy Bible, Galatians 5:22-26).
    - Christians are required to pursue Love/God in order to be filled overflowing with the fruit of the Spirit of God (Holy Bible, I Corinthians 13:1; 14:1).

- The fruit of the spirit of God is love, joy, peace, patience, kindness, goodness, gentleness, faithfulness, and self-control. If Christians have Love they have all of the ingredients of the fruit of the Spirit of God. Likewise, if Christians do not have Love they do not have any of the ingredients of the fruit of the Spirit of God (Holy Bible, Galatians 5:22-26).
- The Amor of God is the second result of sanctification (Holy Bible, Ephesians 6:10-18).
  - Christians are required to put on the full armor of God in order to stand firm against the devil, principalities and powers of darkness, and fiery darts.
  - The armor of God is the helmet of salvation, the breastplate of righteousness, the shield of faith, the sword of the Spirit is the Word of God, to put on the belt of truth, and to shod your feet with the preparation of the gospel of peace.
- The Gifts of the Holy Spirit of God is the third result of sanctification (Holy Bible, I Corinthians 14:1-19).
  - Christians are not allowed to pursue the spiritual gifts, but, they are allowed to desire them. Once the Christian pursues Love/God, he or she is able to be used by God with the gifts, at the will of the Spirit of God (Holy Bible, I Corinthians 14:1).
  - The gifts used in the ministries are for the equipping of the saints for the work of service to the building up of the body of Christ Jesus, by edification, which means to instruct and improve morals, exhortation, which means to urge, advise, or warn earnestly, and consolation, which means to soothe grief with comfort (Holy Bible, I Corinthians 14:1-19; Ephesians 4:11-13).
  - Furthermore, the secrets of the heart are disclosed by the Spirit of God, in order for an unbeliever or an ungifted person to be convicted by all, and called to account by all, so that the unbeliever or ungifted person will fall on his or her face and worship God declaring that God is really among the Christian being used by God (Holy Bible, I Corinthians 14:23-25).
  - The nine gifts of the Spirit of God are various tongues (angelic tongue which no individual understands (unless the Spirit gives the interpretation), and earthly which are the languages of the world (which utterance is given by the Spirit regardless if the individual knows the language or not), interpretation of tongues, miracles, faith, healing, prophesy, knowledge, wisdom, and discerning/distinguishing spirits (Holy Bible, I Corinthians 12:1-15).


