ARTICLE III: Purpose

The general purpose is to support, educate, advocate for, and advise individuals with a chronic Peripheral Neuropathy including patients, family members, care givers, support persons and other professionals or organizations with a related mission, through meetings, personal contact, publishing of professional articles, advocacy and seminars.

The purpose for which this corporation is organized and operated exclusively is for charitable and educational purposes within the meaning of 501(c)(3) of the Internal Revenue Code.

The purpose of the corporation is to engage in any lawful act or activity for which corporations may be organized under the Nonprofit Corporation Law of the State of Florida, provided, however that the corporation shall only engage in acts or activities that are consistent with and in furtherance of its 501(c)(3) tax-exempt purposes, which are described in other provisions of these articles.

The specific purposes for which this corporation is organized are to educating the public, professionals, and neuropathy patients, their families and caregivers about resources and supporting information about Peripheral Neuropathy via the website at www.neuropathysupportnetwork.org, the free DVD seminar "Coping with Chronic Neuropathy", and via participation in seminars, educational conferences and workshops. The corporation will implement the specific purposes under four major activities:

- (1) Maintenance, operation and monitoring of the website at www.neuropathysupportnetwork.org concurrent with the use of the email address at gene@neuropathysupportnetwork.org to respond to patient questions.
- (2) The distribution of the free DVD "Coping with Chronic Neuropathy" and this distribution may involve additional distribution by The Neuropathy Association Inc., (a 501c3) in New York, New York, or other similar mission groups from time to time during conference/support/summit/educational meetings where copies are made available free of charge.
- (3) The support, training and resources for Neuropathy Support Groups, chapters, patients and others via the website at www.neuropathysupportnetwork.org and the response to submitted information and questions via Email at gene@neuropathysupportnetwork.org.
- (4) The raising of funds for neuropathy research by providing opportunity for optional donations to neuropathy research using the donation envelopes and designation slips sent with the DVD mailings with donations going directly to The Neuropathy Association the 501c3 in New York City which maintains a neuropathy research grant program via their Research Advisory Committee.

NETWORK FOR NEUROPATHY SUPPORT, INC. elects to add the following Articles to the Articles of Incorporation:

ARTICLE VIII: Duration of Corporation

The period of duration of this corporation is perpetual.

ARTICLE IX: Membership Provisions

The membership provisions of the corporation shall be stated in the bylaws of this corporation.

ARTICLE X: Additional Provisions

The property of this corporation is irrevocably dedicated to charitable and educational purposes. Upon the dissolution or winding up of this corporation, its assets remaining after payment, or provision for payment, of all debts and liabilities of this corporation shall be distributed to The Neuropathy Association, Inc., 60 E 42nd Street, Suite 942, New York, NY 10165-0930 which is organized and operated exclusively for charitable and educational purposes and which has established its tax-exempt status under Section 501(c)(3) of the Internal Revenue Code.

No substantial part of the activities of this corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation (except as otherwise provided by Section 501(h) of the Internal Revenue Code), and this corporation shall not participate in, or intervene in (including the publishing or distribution of statements), any political campaign on behalf of, or in opposition to, any candidate for public office.

No part of the net earnings of this corporation shall inure to the benefit of, or be distributable to, its members, directors, officers, or other private persons, except that this corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in these articles.

Notwithstanding any other provision of these articles, this corporation shall not carry on any other activities not permitted to be carried on (1) by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code or (2) by a corporation contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code.
