ARTICLES OF INCORPORATION

The undersigned, a majority of whom are citizens of the United States, desiring to form a Non-Profit Corporation under the Non-Profit Corporation Law of Florida, do hereby certify:

Article I: The name of the corporation shall be Circle of Friends of the Gulfport Eibrary.

Inc.

Article II: The place in this state where the principal office of the corporation shall be into the City of Gulfport, Pinellas County. The street address of the initial principal office is 5501_28th Ave. S., Gulfport, FL 33707.

Article III: The Circle of Friends of the Gulfport Library, Inc has been organized exclusively for charitable and educational purposes, more specifically to enhance the development of library services by fostering community support for literacy and learning. Proposed activities include fund raising, sponsoring programs targeting youth, purchasing books and supplies and recruiting and training volunteers.

Article IV: The Board of Directors shall be elected by the members at the annual membership meeting. The election of officers and the duties of the Board are outlined in the corporation's Bylaws.

Article V: The name and address of the person who is the initial trustees/registered agents of the corporation follows:

Article VI: No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers or other private persons except that the corporation shall be authorized and empowered to pay reasonable compensations for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Third hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including publishing or distributing statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provisions of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under 501 (c)(3) of the IRS code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under the section 170 (c)(2) of the IRS code. Notwithstanding any other provision of these articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation.

Article VII: Upon dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of the section 501 (c)(3) of the IRS code, or shall be distributed to the federal government, or to the state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such

purposes or to such organization as said Court shall determine, which are organized and operated exclusively for such purposes.
