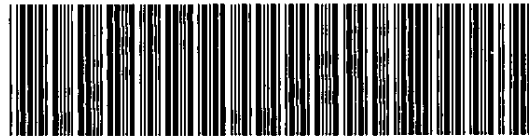

The undersigned incorporator(s) to these Articles of Incorporation hereby forms a corporation under the laws of the State of Florida as follows:

ARTICLE I

NAME OF CORPORATION

The name of this corporation is RIVER CITY CHURCH OF CHRIST INC

ARTICLE II

TERM OF EXISTENCE

The term of existence of the corporation is perpetual.

ARTICLE III

PURPOSE(S)

This corporation is organized for the following purposes:

- A. The primary purpose of the monies collected in this organization is for the spreading of the gospel and to provide benevolent relief to those in need.
- B. To transact any and all lawful business for the benefit of River City Church of Christ Inc., including receiving of contributions and to manage the amounts received for religious and benevolent purposes.
- C. To operate exclusively in any other manner for such religious, charitable and educational purposes as will qualify it as exempt organization under Section 501(c) (3) of the Internal Revenue Code, as amended or under any corresponding provisions of any subsequent federal tax laws covering the distributions to organizations qualified as tax exempt.

ARTICLE IV

Notwithstanding any other provision of the Articles of Incorporation, this Corporation shall not conduct or carry on any activities not permitted to be conducted or carried on by any organization that shall be exempt under Section 501(c)(3) of the Internal Revenue Code and its Regulations, now existing or hereafter amended or by any organization contributions to which are deductible under Section 170(e)(2) of the Internal Revenue Code and its Regulations, now existing or hereafter amended.

ARTICLE V

The affairs of the corporation shall be managed by a Board of Directors consisting of not less than three (3) Directors. The Directors shall be elected annually by a majority vote of the members of the congregation.

AMENDMENTS

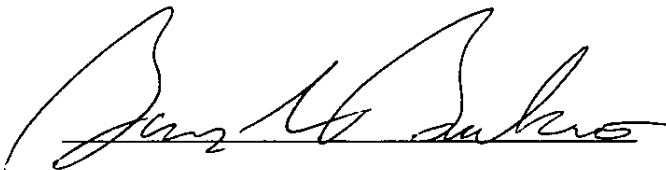
This corporation reserves the rights to amend or repeal any provision contained in the Articles of Incorporation, or any amendment hereto, by a majority vote of the members of the congregation.

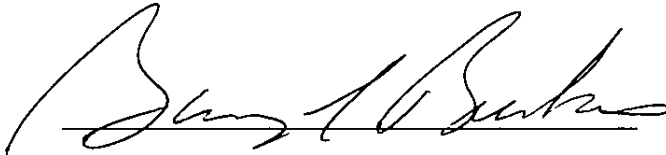
