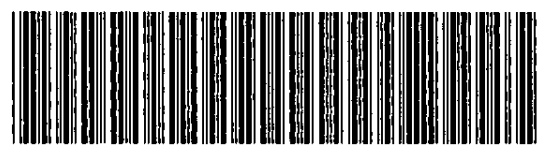

Article III Purpose

The purpose of this organization is to teach and preach the Gospel of Jesus Christ to believers and non-believers, feed those that are hungry, clothes those that are in need and provide bible instruction through bible study classes. Preaching and teaching will take place twice weekly and also at other times by invitations. Church services will be on Sunday mornings and Thursday nights. Services will be 2 -3 hours long. Times will be spent studying the bible and other church activities.

Article VIII

Said organization is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code. Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or a state or local government, for a public purpose. Any such assets not disposed of shall be disposed of by a court of competent jurisdiction in the county in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
