ARTICLES OF AMENDMENT TO PALLAHASSEE FLORIDA

ARTICLES OF INCORPORATION

FAITH CHRISTIAN CENTER CHURCH OF TALLAHASSEE, INC.

Pursuant to the provisions of Section 617, Florida Statutes, FAITH CHRISTIAN CENTER CHURCH OF TALLAHASSEE, INC., a Florida non profit corporation (the "Corporation"), adopts the following Articles of Amendment to its Articles of Incorporation:

- 1. The name of the Corporation is FAITH CHRISTIAN CENTER CHURCH OF TALLAHASSEE, INC.
- 2. The Articles of Incorporation were filed on July 12, 2011 and assigned document number N11000006640.
 - 3. The effective date of this amendment shall be April 20, 2014.
- 4. Article I of the Articles of Incorporation of the Corporation is hereby amended in its entirety to read as follows:

"ARTICLE I. NAME

The name of the corporation is IMPACT CHURCH OF TALLAHASSEE, INC."

- 5. The foregoing amendment was adopted and approved by the Board of Trustees of the Corporation on December 26, 2013.
- 6. There are no members of the Corporation entitled to vote on such Articles of Amendment to Articles of Incorporation.
