

Article 3 cont

The corporation shall promote, within the territory covered by the charter from time to time granted it by the Boy Scouts of America and in accordance with the Congressional Charter, Bylaws and Rules and Regulations of the Boy Scouts of America, and Deltona Pack 312, the scouting program of promoting the ability of boys and young men and women to do things for themselves and others training them in scout craft, and teaching them patriotism, courage, self-reliance, and kindred virtues, using the methods which are now in common use by the Boy scouts of America.

Article IV cont

All corporate powers shall be exercised by or under the authority of, and the business of the Corporation shall be managed under the direction of the Board of Directors. The number of the initial Board of Directors for the Corporation shall be as provided for the Corporation's Bylaws. It is there provided that the number of Directors may be increased or decreased, as provided in the Corporation's Bylaws. Such Directors are to be elected or appointed in the manner proved for by the Corporation's bylaws.

Article 8

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Third hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Article 9

The property and assets of the corporation are irrevocably dedicated to the charitable and educational purposes of carrying out the program of the Boy Scouts of America.

In the event of the dissolution of final liquidation of the corporation or upon the revocation or termination of its charter from the Deltona Baptist Church, none of such property or assets or proceeds there from shall inure to the benefit of any individual but shall, after all liabilities and obligations of the corporation have been paid or satisfied or provision otherwise made therefore, be distributed (a) to another local cub scout pack of the Boy Scouts of America as specified by the Deltona Baptist Church to be used for charitable and educational purposes, or (b) in the absence of such specification, to the Central Florida Council of the Boy Scouts of America to be used for charitable and and educational purposes, contemplated that in either instance such property and assets shall continue to be devoted to the furtherance of scouting in Florida.
