## ARTICLE II                      PURPOSES

The purposes for which the Club is organized are exclusively religious, charitable, scientific, literary or educational within the meaning of section 501c (3) of the Internal Revenue Code of 1954 or the corresponding provision of any future United States Internal Revenue Law.

Club purposes are:

- A. To provide continuity of the Friendship Force activities and of volunteer involvement
- B To provide dissemination of information to Club members and to interested persons in  
the community
- C. To provide an instrument for raising funds
- D. To recruit and maintain an active membership file
- E. To provide an orderly means of assembling and retaining pertinent records for use in  
establishing and assisting exchange committees

Notwithstanding any other provisions of these articles, this organization shall not carry on any other activities not permitted to be carried on by an organization exempt from Federal Income Tax under section 501c(3) of the Internal; Revenue Code of 1954 or the corresponding provision of any future United States Internal Revenue law.

## ARTICLE IV BOARD OF DIRECTORS

### Section I

The Board of Directors shall consist of the elected officers of the Club, the present Exchange Directors, the Standing Committee Chairman, and any additional members appointed by a majority vote of the existing Board of Directors. The immediate Past President and immediate Past Exchange Directors may sit on the Board for two (2) years and may be re-
