Amended Articles:

Article 3

Purpose

The purpose Starting Over Outreach Center, Inc. is organized for charitable, religious, educational and scientific purpose, including, for such purpose, the making of distributions to organizations that qualify as exempt organizations under section 501 © 3 of the Internal Revenue Code, or corresponding section of any future federal tax code. Upon dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)3 of the Internal Revenue Code to the federal government or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not disposed of shall be disposed of by Court of Common Pleas of the County in which the principle office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

Article 4

Form of Government

Each Director shall have one vote. All voting at meetings shall be done personally and no proxy shall be allowed. Only participating members, eighteen (18) years of age or older, will be eligible to vote on issues brought before the Board. There must be a 2/3rd majority vote of the Board to replace any open position.

The treasurer shall be the corporate and legal officer in custody of the corporate seal and shall retain and maintain current documents and records necessary for the corporation, including registering with all agencies as needed.

Removal of Officers:

Officers may be removed at any time by the Board by the affirmative vote of a majority of the Board.

Article 10

Conflicts of Interest

Whenever a director or officer has a financial or personal interest in any matter coming before the board of directors, the board shall ensure that:

- 1. The interest of such officer or director is fully disclosed to the board of directors.
- No interested officer or director may vote or tobby on the matter or be counted in determining the existence of a quorum at the meeting of the board of directors at which such matter is voted upon.
- 3. Any transaction in which a director or officer has a financial or personal interest shall be duly approved by members of the board of directors not so interested or connected as being in the best interests of the organization.
- 4. Payments to the interested officer or director shall be reasonable and shall not exceed fair market value.
- 5. The minutes of meetings at which such votes are taken shall record such disclosure, abstention, and rationale for approval.

Article 11

Dissolution

The asset of Starting Over Outreach Center, Inc., a FLORIDA corporation, is irrevocably dedicated exclusively for religious, charitable and/or education purposes. In the event of dissolution of the corporation, the General Board shall, after paying or making provisions for the payment of all of the liabilities of the corporation, dispose of all the assets of the corporation, so as to insure that the remaining assets will not inure to the benefit of any private person or persons, but that all remaining assets will be

Additional Articles:

Article 9

Selection and terms of Officers:

The officers of the Starting Over Outreach Center, Inc., except for the president, may be elected or appointed, shall be chosen annually and shall hold their respective offices until their resignation, removal, or other disqualification from service, or until their respective successors shall be elected.

Duties of Officers:

Duties of President: The President is general manager and chief executive officer of the corporation and has, subject to the control of the Starting Over Outreach Center, Inc., general supervision, direction, and control of the business and officers of the corporation. The President shall preside at all meetings of the members and at all meetings of the Starting Over Outreach Center, Inc..

Duties of Vice President: In the absence or disability of the President, the Vice designated by Starting Over Outreach Center, Inc., shall perform all the duties of the President and, when so acting, shall have all the powers of, and be subject to all the restrictions upon, the President. The Vice Presidents shall have such other powers and perform such other duties as from time to time may be prescribed for them respectively by Starting Over Outreach Center, Inc..

Duties of Secretary: It shall be the duty of the secretary to keep an accurate record of the proceedings of the meetings of the board and of the yearly or special congregational meetings of business, and all such other duties as pertain to this office as may be prescribed by the Board.

Duties of Treasurer: The treasurer shall oversee the care and custody of all funds, securities and deposits of the church in such bank or banks as the board of directors may select. The board of directors shall, by resolution fix all matters of signatures at the point of taking office, which shall continue during the tenure of office, or until changed by the board of directors. The treasurer shall at all reasonable time exhibit his/her books or accounts to any member of the board of directors or committee appointed by
