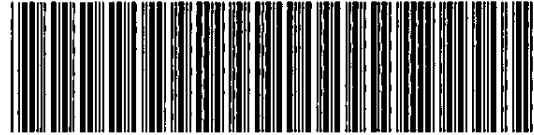





PURPOSE

This corporation is organized exclusively for charitable and educational purposes, including but not limited to aiding individuals, families, and other organizations affected by diabetes and other kidney related diseases; providing them with any financial support required as a result of diabetes and/or other kidney related diseases. To this end, the corporation shall at all times be operated exclusively for charitable purposes within the meaning of Section 501(c)(3) of the current Internal Revenue Code, as now enacted or hereafter amended. Additionally, funds, whether income or principal, and whether acquired by gift or contribution or otherwise, shall be devoted to said purposes as well and raising awareness and educating the community of the aforementioned causes.

DISSOLUTION OF ASSETS

In the event of the organization being dissolved, the monies and assets that remain after such dissolution and the satisfaction of all debts and liabilities shall be donated to a beneficiary deemed eligible by the officers of the organization, under the Articles of Incorporation Purpose.
