ARTICLES OF INCORPORATION

FOR

THE FOUNDATION OF THE WORD OUTREACH MINISTRIES, Inc.

ARTICLE III – PURPOSE

The corporation is organized exclusively for charitable, religious, and educational purposes. In pursuit of these purposes, the corporation may also do any of the following: to purchase, lease, own or otherwise acquire real estate, and to mortgage and encumber the same. To sell fundraising products that will fund the organization. To purchase needed supplies: food, equipment for broadcasting events hosted and interest therein. To do any legal activity to the same extent a natural person might or could do as a principle or agent. To execute generally such powers as may be vested in a corporation under the non-profit corporation laws of the State of Florida.

The corporate mission is to work primarily with the homeless, low income families and trouble teenagers so that they may connect with all community resources to enable the betterment of quality of life. This includes community resources involved in providing food and clothing, serving as a liaison between the community and the individuals, providing a facility for mentoring problematic teenagers where they can come and receive mentoring via physical sport and religious mentoring.

ARTICLE VIII - EFFECTIVE DATE

The effective date for this corporation shall be: July 18, 2011

ARTICLE IX - DISTRIBUTION OF ASSETS UPON DISSOLUTION

No, person, firm, or corporation shall ever receive any dividends or profits from the undertaking of this corporation, and upon dissolution of this organization, all of its assets remaining after payment of all costs and expenses of such dissolution shall be distributed to an organization or organizations which have qualified for exemption under Section 501(c)(3) of the Internal Revenue Code, or to the Federal Government, or to a State or Local government, for a public purpose, and none of the assets will be distributed to any member or officer of this corporation for private inurement.

ARTICLE X - GENERAL GUIDELINES FOR OPERATIONS

Notwithstanding any other provision of these articles, this corporation will not carry on any activities which are not permitted to be carried on by a corporation exempt from Federal Income Tax Section 501 (c)(3) of the Internal Revenue Code of 1954 or the corresponding provision of any future United States Internal Revenue Law. This includes the regulations relating to the corporation in its public support of political candidates. The corporation will not be involved in providing corporation assistance in obtaining voter support of any political candidate. No corporation financial support will be provided for any political party. No public remarks of support or degradation will be part of the activity sponsored by this corporation.
