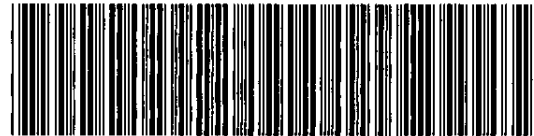

**ARTICLES OF A 501(c)(3) NOT FOR PROFIT CORPORATION UNDER THE LAWS
OF THE STATE OF FLORIDA: THE ALLIANCE OF LOVE, INC.**

ARTICLE I: NAME

The Name of the Corporation is: Alliance of Love, Inc.

ARTICLE II: PLACE OF BUSINESS/ MAILING ADDRESS:

The principle place of Business is located at and the mailing address is: 14211 South West 155th
Street, Miami, FL 33177.

ARTICLE III: PURPOSE

The Purposes of the Formation of the Corporation are: for the Charitable and Educational purposes
of **rebuilding** a School and Orphanage in Leogane, Haiti, that housed approximately 85 children and
schooled them with a staff of 20 people, and that was destroyed in the earthquake of September 12,
2009, and to perform any and all other services to Haitian students and orphans through the
organization known in Jeremie as "Christian Haitian Orphanage Development Jeremie" or CHODPJ;

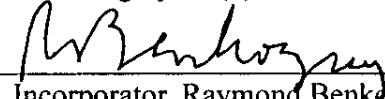
