

ARTICLES OF INCORPORATION

In compliance with Chapter 617, F.S., (Not for Profit)

EFFECTIVE DATE oglocky

We the undersigned natural persons of the age of twenty-one years or more, acting as incorporators of a corporation under the state of Florida adopt the following Articles of Incorporation for such corporation:

Article I NAME

The name of the corporation is PFLAG Lecanto, Inc.

Article II PRINCIPLE OFFICE (street address)

The address where the corporation conducts business is 3254 W Lantana Drive Beverly Hills, Fl 34465





Article III

PURPOSE OF THE CORPORATION

The purpose or purposes for which the corporation is organized are:

- a) To hold and manage property and funds for charitable and educational purposes, including the assistance and support of charitable and educational institutions, associations and undertakings.
- b) To provide a support system for families and friends of lesbians and gays in their effort to understand, accept, and support their children with love and pride.
- c) To provide education for individuals and the community at large on the nature of homosexuality.
- d) To support the full human rights and civil rights of lesbians and gays
- e) To speak out and act whenever necessary to defend and enhance those human rights and civil rights.

Article IV MANNER OF ELECTION (Board of Directors)

The Board of Directors is elected by the members.

Article V MEMBERS

The Corporation is to have one class of members. The Corporation shall have members designated as those who pay dues as determined by the Board of Directors and are members of the PFLAG organization and the Lecanto chapter of PFLAG. Membership entitles the individual to one vote.

Article VI <u>INITIAL OFFICERS AND/OR DIRECTORS</u>

Article VII <u>EFFECTIVE DATE</u>

The effective date of the Corporation will be SEPTEMBER 1, 2011.

Article VIII EARNINGS

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers or other private persons, except that the corporation shall be authorized to make payments and distributions in furtherance of the purposes of this corporation.

Article IX LIMITATIONS ON ACTIVITIES

No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for office.

Article X OTHER LIMITATIONS OF ACTIVITIES

Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from Federal income tax under section 501(c)3 of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law) or, (b) by a corporation, contributions to which are deductible under section 170(c)2 of the Internal Revenue Code of 1954 (or corresponding provision of any future United States Internal Revenue Law).

Article XI DISSOLUTION OF THE CORPORATION

Upon the dissolution of the corporation, the Board of Directors shall, after paying or making provision for the payment of all liabilities of the corporation, dispose of all of the assets of the corporation exclusively for the purposes of the corporation in such a manner, or to such organization of organizations organized and operated exclusively for charitable, education, religious, or scientific purposes as shall at the time qualify as an exempt organization or organizations under section 501(c)3 of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law), as the Board of Directors shall determine. Any such assets not so disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations is said Court shall determine, which are organized and operated exclusively for such purposes.

Article XII ORGANIZATION AND OPERATION

This corporation is organized and shall be operated exclusively for charitable and education purposes within the meaning of the section 501(c)3 of the section of the Internal Revenue Code of 1954.
