

## Howard W. Blake High School of the Arts Orchestra Parent Volunteer Organization Articles of Incorporation

#### Attachment 1

#### **PURPOSE:**

The PVO is organized within the Howard W. Blake High School of the Arts to promote community and area support of the Howard W. Blake Orchestra Program, to provide financial assistance and services for the orchestra program, to aid in the development of student interest, to promote student leadership and responsibility, to act as a liaison between the orchestra program and the parents and community, and to plan and carry out fund raising for support of activities and projects of the orchestra program.

No substantial part of the activities of this organization shall consist of carrying on propaganda, or otherwise attempt to influence legislation, except as provided in section 501(h) of the Internal Revenue Code of 1986, and the organization shall not participate or intervene in any political campaign (including the publishing or distribution of statements) on behalf of, or in opposition to, any candidate for public office, except as provided in section 501(h) of the Internal Revenue Code of 1986.

Notwithstanding any other provision of these articles, the organization shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue law), or (b) by an organization to which contributions are deductible under section 1 70(c)(2) of the Internal Revenue Code of 1986 (or corresponding provision of any future United States internal Revenue law).

The property of this organization is irrevocably dedicated to section 501 (c)(3) exempt purposes and no part of the net income or assets of this organization shall ever inure to the benefit of any director, PVO coordinator or member thereof, or to the benefit of any private purpose.

#### Attachment 2

#### **Election of PVO Coordinators:**

- A. PVO coordinators shall be elected not later than the May regularly scheduled meeting or a special called meeting announced to members at least two weeks in advance.
- B. Terms of officers shall be Aug 1 June 15.
- C. A PVO coordinator may be removed by a two-thirds vote of the executive board or a majority vote by the association membership for failure to execute the duties of office as stated in these bylaws.
- D. Should a vacancy occur in the position of a PVO coordinator as the result of resignation, removal, or failure to no longer qualify for service as defined by these bylaws, the nominating committee shall make a recommendation to fill the vacant position. The nominee will be voted upon by the membership at any regular or specially called meeting at the earliest possible date, but not to exceed 60 days after acknowledgement of the vacancy. The previously elected PVO coordinator shall be allowed to continue in his or her position until said election occurs except in instances of removal, whereupon the PVO coordinators shall immediately assume the responsibilities of the removed PVO coordinator.
