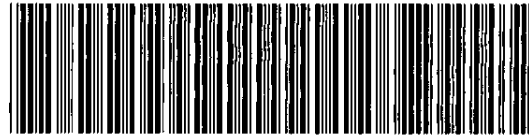

# ARTICLES OF INCORPORATION OF donthaveaname.com, Inc.

RESOLVED, that the undersigned acting as incorporators of a Florida corporation pursuant to Chapter 617, Florida Statutes, (Not for Profit), adopt the following Articles of Incorporation for such corporation.

## Article I

### Name

The name of the corporation shall be donthaveaname.com,Inc

## Article II

### Principal Office

## Article III

### Purpose

The by-laws of the church shall be made, altered, amended or rescinded by a majority vote of the membership present in the manner provided by the By-laws.

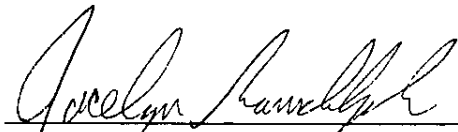
**Article XI**
