

### **By Laws Of** Deep Calleth Deep



## Article I Name and Purpose

Section 1.01. Name. Deep Calleth Deep

Section 1.02. Purpose. The association is organized to improve the overall quality of life and make the greatest impact as guided by the Holy Spirit to inform mankind Gods plan of eternal life. While, implementing many programs to serve and enhance their lifestyle for the charitable support of spiritual, emotional, educational, physical and socioeconomic well being of men, women and children, within the meaning of section 501 (c) (3) of the Internal Revenue code.

# Article II Authority and duties of officers

**Section 2.01**. The officers of the association shall be a President, Vice President, Treasure and Secretary.

**Section 2.02.** President. The President shall preside at all meetings of the association. The President shall have sole power to make the final decisions in all matters concerning the association. He shall see that all provisions of the By-Laws and rules and regulations of the association are enforced.

**Section 2.03.** Vice President. The Vice President shall assist the President and perform such duties as may be assigned to him by the President and in case of absence to act, the Vice President shall perform the President's duties.
