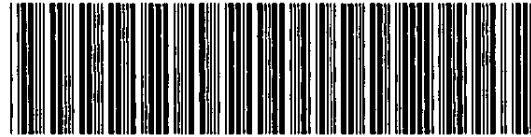

Article IX


