The undersigned, a majority of whom are citizens of the United States, desiring to form a Non-Profit Corporation under the Non-Profit Corporation Law of State of Florida, do hereby certify:

ARTICLE I COPORATE NAME

The name of this Corporation shall be Polk County Family Week, Inc.

ARTICLE II PRINCIPAL PLACE OF BUSINESS

The place in this state where the principal office of the Corporation is to be located as follows:

1700 North Lake Eloise Drive Winter Haven, Florida 33884 Polk County, Florida.

ARTICLE III CORPORATE PURPOSE

The corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

ARTICLE IV MANNER OF ELECTION OF THE BOARD OF DIRECTORS

This Corporation shall initially have Seven (7) members of the Board of Directors who shall serve without compensation. The number of members of the Advisory Board may be changed, from time to time, by the By-laws of the Corporation, but shall never be less than three (3). The members of the Board of Directors shall be members of the Corporation. The By-laws may indicate the manner of the election of the members of the Board of Directors. The Board of Directors seats may be arranged with staggered terms and election years, as specified in the By-laws. Board of Directors action shall require a majority of those present (in person or by electronic medium) to constitute an act of the Board of Directors. At least half (1/2) of the currently elected members of the Advisory Board shall be required to be present (in person or by electronic medium) to constitute a quorum to enable the Board of Directors to take any action.

ARTICLE V INITIAL OFFICERS AND DIRECTORS

The Officers of the Corporation shall be a President, Vice President, Secretary and Treasurer and such other officers as may be identified by the Corporation By-laws. ARTICLE VIII TERM OF EXISTENCE

This Corporation commenced upon filing and will continue to exist perpetually.

ARTICLE IX EXEMPTION STATUS AND LIMITATIONS OF CORPORATE POWERS

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III hereof.

No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

ARTICLE X DISSOLUTION

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the

corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.




