Treasure Florida's Children, Inc., Articles of Incorporation

ARTICLE III, Purpose

Treasure Florida's Children, Inc., is organized to receive and administer funds and operates exclusively for social welfare purposes within the meaning of section 501(c)(4) of the Internal Revenue Code of 1986, or the corresponding section of any future federal tax code (the "Code"), and in particular to;

- (a) Promote a regional focus to address and solve issues involving the common good of children and families;
- (b) Advocate for children and family issues in the local political arena;
- (c) Coordinate local efforts involving legislation of issues involving children and families;
- (d) Make the general public aware of legislative issues that affect children and families, and
- (e) Encourage lawmakers, candidates and the general public to support laws, referendums and policies that will make children and family issues a priority in the Treasure Coast.

ARTICLE IV, Manner of Election

The initial Directors are appointed by the incorporators. Directors shall be elected by the affirmative vote of a majority of the Board of Directors at its annual meeting. Vacancies occurring in the Board of Directors by reason of death, resignation, removal or other inability to serve shall be filled by the affirmative vote of a majority of the remaining directors. A director elected to fill a vacancy shall serve for the unexpired portion of the term. Directors shall be eligible for re-election.

ARTICLE VIII, Restriction on Operations

No part of the net earnings of the corporation shall inure to the benefit of, or be distributed to its directors, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article II. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under Section 501 (c) (4) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

ARTICLE IX, Dissolution and Disposition of Corporate Assets

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501 (c) (4) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as such court shall determine, which are organized and operated exclusively for such purposes.
