**ARTICLES OF INCORPORATION
OF

The undersigned, acting as incorporators of a corporation pursuant to Chapter 617, Florida statutes, adopts the following Articles of incorporation.

I

The name of the corporation shall be:
GRIMES CARE ASSISTED LIVING FACILITY INC.

II

The principle office of the Corporation shall be located at 7283 Nottinghamshire Dr. Jacksonville, Florida 32219

III

The specific purposes for which the corporation is organized are (1) Specific of the provision of living facilities with the intent to positively change and enhance the quality of life of the elderly. (2) The provision of permanent and temporary transitory housing for the elderly. (3) To serve as a referral service catering to the psychological and physical needs of the elderly. (4) The purposes for which the corporation is organized are exclusively charitable and educational within the meaning of section 501 © (3) of the Internal Revenue Code of 1986 or any corresponding provision of any future Internal Revenue law.

No part of the net earning of the corporation shall insure to benefit of, or be distributable to it's members, trustees, office, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable

compensation for services rendered and to make payment and distributions in furtherance of the purpose set forth in Article Third hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501 © (3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170 © (2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

"Notwithstanding any other provisions of these articles this corporation shall not except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purpose of this corporation"

VI

Upon dissolution of the corporation either as an act of law or by resolution of the Board of Directors assets of the corporation shall be distributed to a non-profit 501 © (3) corporation. "However" if the named recipient is not in existence or no longer qualified as a distributed to a fund, foundation, or organization which is and operated exclusively for specific in section 501 © (3) of the internal revenue code of 1986 or any corresponding provision of any future internal revenue law.

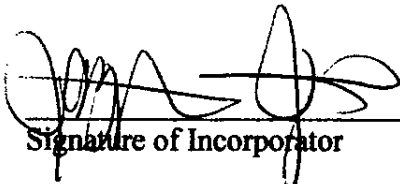
