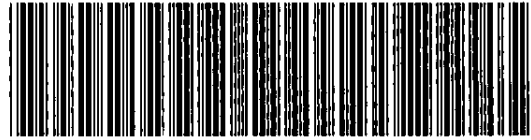

**ARTICLES OF INCORPORATION
OF
BREATH OF LIFE DEVELOPMENT FOR COMMUNITIES INC.**

The undersigned acting as incorporators of a corporation pursuant to Florida Corporation Law Statute 617, adopts the following Articles of Incorporation.

**ARTICLE I

5. To operate exclusively for charitable, religious and educational purposes within the meaning of section 501 (c) (3) of the Internal Revenue Code of 1986 and any future Internal Revenue Law

**ARTICLE IV
DISSOLUTION**

Upon dissolution of the corporation either as an act of law or by resolution of the Board of Director assets of the corporation shall be distributed to a non-profit 501 (c) (3) corporation. "However" if the named recipient is not in existence as a distributee, or is unwilling to accept the distribution, the assets will be distributed to a fund, or foundation, or organization which operates exclusively for purposes specified in section 501 (c) (3) of the Internal Revenue Code of 1986 of any corresponding provision of any future Internal Revenue Law.

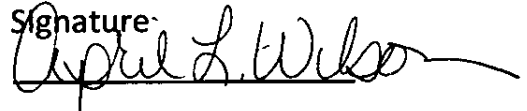
