ARTICLES OF INCORPORATION OF

J. E. S. U. S. Foundation, Corp.

A FLORIDA NOT-FOR-PROFIT ORGANIZATION

ARTICLE I NAME

The name of this corporation is J. E. S. U. S. Foundation, Corp.

ARTICLE II PRICIPAL OFFICE

The principal place of business and mailing address of this corporation is 10960 Beach Boulevard, Lot 199, Jacksonville, FL 32246

ARTICLE III PURPOSE

This corporation is a nonprofit academic Foundation and is not organized for the private gain of any person. It is organized under the Nonprofit Corporation Law for Educational purposes. The specific objective for which this Foundation is organized is two-fold namely, educational-cultural exchange and missions. Firstly, it is to (a) enhance the U.S. National concern in promoting the globalization of educational, inter-cultural and intra-cultural interest across the globe; and (b) it is to target and connect great talents of young men and women globally, under a united forum, in order to create a life-long educational, research, technological, inter- and intra-cultural network and development for the growing millennium. Secondly, it is mission-oriented as a ground for bringing education to the less privileged, and culturally helping the helpless in various community of the world such as orphans, widows and prisoners, also aiding development in war-torn zones of the new Sudan and planting churches where need be. Initially, this Foundation generally will:

- (1) Help qualified scholars from developing countries gain access upon thorough screening, to uninterrupted/ undisturbed training and technological advancement for eventual use in their respective home countries, upon completion of their terms as Exchange Visitors (EV).
- (2) In retrospect this organization will also source placement for Americans who wishes to take advantage of studying or teaching abroad, through government generated educational bodies like Fulbright Grants and scholarships from other bodies within the United States. In future, such scholarships may come from other international bodies as this corporation may find applicable.
- (3) Propose on-Demand sourcing of financial aids and on-hand support for properly screened, highly qualified, intelligent, ethical and goal-oriented international scholars.

- (4) Offer salubrious global educational services, towards the holistic development, building and creative ability of the professional.
- (5) Help local primary, secondary and tertiary schools in war-torn countries like the new Sudan to develop school curriculum, provide needed infrastructure and materials, to meet up with the universal schooling standards, using funds generated from operations.

On the long run our objective will include:

- (1) Establishment of Educational Centers around the globe on the long-term, to enhance global networking of professional scholars for global research purposes.
- (2) Joint promotion of educational services between the developed, developing and the under-developed world.
- (3) Engage in full evaluation processing of transcripts for international student admissions into the American educational system.

ARTICLE IV MANNER OF ELECTION

Appointment of directors for this corporation is going to be both permanent for the founder and every four years, where applicable for other directors. There is going to be a Chairman / Chief Executive Director, who is also the founder of the foundation, and is deemed the "Responsible Officer" (RO). This is the only position of a permanent director's office in this foundation. Except for either voluntary resignation at 65 years of age, permanent disability or demise of the founder, or as otherwise amended by the corporation, will the founder cease to operate in this capacity. There will be at least two other directors, who during the course of operation, will be deemed as "Alternate Responsible Officers" employed based on qualifications as follows: (1) Director of Operations (Admission & Screening) and (2) The Director of Marketing (Sales and Public Relations). At this initial stage we have volunteer directors willing to sacrifice time and energy as required for the stability of this new foundation.


